

ORDER 2015-02
AN ORDER OF THE INDIANA GAMING COMMISSION
CONCERNING THE VOLUNTARY EXCLUSION PROGRAM
CASE NO. VEP-15-02

On or about January 5, 2010, John Doe #02 submitted an application to the Indiana Gaming Commission ("Commission") to participate in the Voluntary Exclusion Program ("VEP") for a minimum of five years. Pursuant to the terms of the VEP, a participant remains in the program until the exclusion period expires and the participant submits a written request for removal. 68 Ind. Admin. Code § 6-3-5. A VEP participant agrees that if he or she violates the terms of the program and enters the gaming area of a facility under the jurisdiction of the Commission before he or she is removed from the program by the Commission, he or she willingly forfeits any money or thing of value won from or owed to the participant as the result of a wager at a casino. 68 Ind. Admin. Code § 6-3-2(g). The casino must withhold forfeited winnings and remit them to the Commission. 68 Ind. Admin. Code § 6-3-2(g).

On or about February 8, 2015, John Doe #02 was a VEP participant and was discovered to be present at Ameristar Casino East Chicago, LLC ("Ameristar"). At that time, John Doe #02 had won \$3,000.00 in cash equivalents from Ameristar. Ameristar withheld the winnings as required by Commission regulations. Commission staff seeks approval for remittance of the winnings to the Commission, less applicable taxes, in fulfillment of John Doe #02's VEP participation.

The Commission, after reviewing this matter:

APPROVES

the remittance of \$3,000.00, less applicable taxes, as required by the program. 68 Ind. Admin. Code § 6-3-2(g).

Pursuant to Ind. Code § 4-21.5-3-5, this ORDER becomes effective fifteen days following receipt of the Order of the Indiana Gaming Commission.
