

ORDER 2016-251

**AN ORDER OF THE INDIANA GAMING COMMISSION PROSPECTIVELY RENEWING
THE CASINO OWNER'S LICENSE AND POWER OF ATTORNEY FOR AZTAR
INDIANA GAMING COMPANY, LLC d/b/a TROPICANA EVANSVILLE**

Pursuant to Ind. Code art. 4-33 and Title 68 of the Indiana Administrative Code, the Indiana Gaming Commission ("Commission") issued a casino owner's license to Aztar Indiana Gaming Corp. ("Aztar Corp.") effective December 8, 1995. Aztar Corp. was later restructured as a limited liability company – Aztar Indiana Gaming Company, LLC. On January 14, 2010, by Order 2010-1, the Commission approved the application for transfer of ownership of the operating assets of Aztar Indiana Gaming Company, LLC to Tropicana Entertainment, Inc.; however, Aztar Indiana Gaming Company, LLC (hereinafter referred to as "Tropicana") retained the casino owner's license. The Commission has renewed the license annually since inception, most recently on November 12, 2015, which renewed the license through December 4, 2016.

On August 22, 2016, Tropicana requested renewal of its casino owner's license and submitted payment of the annual renewal fee in the amount of \$5,000.

On November 12, 2015, the Commission renewed a written power of attorney identifying Ronald Gifford as trustee-in-waiting for Tropicana. Order 2015-194 stated this approval would expire "upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of Tropicana's casino owner's license; or (2) modifies or withdraws the approval" of Mr. Gifford. On August 22, 2016, Tropicana indicated that it desires to maintain Mr. Gifford as trustee-in-waiting.

COMMISSION ACTION

Pursuant to Ind. Code § 4-33-6-12, the Commission has found that Tropicana has substantially complied with the directives of Ind. Code art. 4-33 and Title 68 of the Indiana Administrative Code; therefore, Tropicana is suitable to hold a casino owner's license. The Commission **GRANTS** renewal of the casino owner's license for a period of one year subject to Tropicana maintaining its casino gambling operation, riverboat, hotel, and pavilion in substantial compliance with all applicable state and local laws, including but not limited to, Commission regulations, resolutions, orders, and/or other Commission directives relating to the casino owner's license, or the lawful operation or conduct of gaming in Indiana. The renewal of the casino owner's license is valid for a period of one year beginning December 5, 2016, through December 4, 2017.


Furthermore, the Commission **APPROVES** renewal of the power of attorney identifying Mr. Gifford as trustee-in-waiting for Tropicana. The renewal expires upon subsequent Commission order that either: (1) addresses the renewal of Tropicana's casino owner's license; or (2) modifies or withdraws the approval of Mr. Gifford as approved herein.

According to Ind. Code ch. 4-21.5-3, this order is effective fifteen days after it is served.


