## ORDER 2020-18 AN ORDER OF THE INDIANA GAMING COMMISSION CONCERNING RENEWAL OF SUPPLIER'S LICENSES

In accordance with Ind. Code art. 4-33, Ind. Code art. 4-35, and 68 Ind. Admin.
