ORDER 2023-172 IN RE SETTLEMENT AGREEMENT EVERI PAYMENTS, INC. 23-EVERI-02

Order 2023-172 involved a settlement agreement with Everi Payments, Inc. and includes one count. The supplier failed to renew an occupational license on two separate occasions. Everi has agreed to a monetary settlement of \$1,500 in lieu of disciplinary action.

ORDER 2023-173 IN RE SETTLEMENT AGREEMENT GENESIS GAMING SOLUTIONS, INC. 23-GGS-01

Order 2023-173 involved a settlement agreement with Genesis Gaming Solutions and includes one count. The supplier failed to renew an occupational license on five separate occasions, all level one licensees. Genesis has agreed to a monetary settlement of \$10,000 in lieu of disciplinary action.

ORDER 2023-174 IN RE SETTLEMENT AGREEMENT IGT 23-IGT-03

Order 2023-174 involved a settlement agreement with IGT and includes one count. The supplier violated the rules for shipping electronic gaming devices on two separate occasions. IGT has agreed to a monetary settlement of \$3,000 in lieu of disciplinary action.

ORDER 2023-175 IN RE SETTLEMENT AGREEMENT INTERBLOCK LUXURY GAMING PRODUCTS, LLC 23-IB-03

Order 2023-175 involved a settlement agreement with Interblock Luxury Gaming Products, LLC and includes one count. The supplier incorrectly set-up electronic gaming devices at two Indiana casinos. Interblock has agreed to a monetary settlement of \$1,000 in lieu of disciplinary action.

ORDER 2023-176 IN RE SETTLEMENT AGREEMENT THE UNITED STATES PLAYING CARD COMPANY 23-USPC-01

Order 2023-176 involved a settlement agreement with The United States Playing Card Company and includes one count. The supplier failed to file a level one license application in a timely manner and allowed a non-licensed individual to perform the duties of a level one licensee for 309 days. U.S. Playing Card Company has agreed to a monetary settlement of \$7,500 in lieu of disciplinary action.

Casino License Matters:

ORDER 2023-177 IN RE SETTLEMENT AGREEMENT AMERISTAR CASINO EAST CHICAGO, LLC 23-AS-03

Order 2023-177 involved a settlement agreement with Ameristar East Chicago and includes three (3) counts. In count one, Ameristar violated the rules of the soft count process when they failed to count a bill validator box and failed to secure assets. In count two, Ameristar violated the sensitive key rules and failed to report a missing key to the Commission in a timely manner. In count three, Ameristar violated the rules on table fills. Ameristar has agreed to a monetary settlement of \$10,500 in lieu of disciplinary action.

ORDER 2023-178 IN RE SETTLEMENT AGREEMENT AZTAR INDIANA GAMING CO., LLC d/b/a BALLY'S EVANSVILLE 23-BE-04

Order 2023-178 involved a settlement agreement with Bally's Evansville and includes two (2) counts. In count one, Bally's violated the rules on the multiple transaction log when they failed to record an entry for a \$10,000 transaction. In count two, Bally's violated the rules on the vendor log. Bally's has agreed to a monetary settlement of \$5,500 in lieu of disciplinary action.

ORDER 2023-179 IN RE SETTLEMENT AGREEMENT BELTERRA RESORT INDIANA, LLC 23-BT-02

Order 2023-179 involved a settlement agreement with Belterra Resort Indiana, LLC and includes three (3) counts. In count one, Belterra violated the licensing rules by failing to notify the Commission of a termination in a timely manner. In count two, Belterra allowed a minor to obtain access to the casino floor. In count three, Belterra violated the rules of

the Voluntary Exclusion Program. Belterra has agreed to a monetary settlement of \$2,250 in lieu of disciplinary action.

ORDER 2023-180 IN RE SETTLEMENT AGREEMENT BLUE CHIP CASINO, LLC 23-BC-04

Order 2023-180 involved a settlement agreement with Blue Chip Casino, LLC and includes one count. Blue Chip Casino violated the rules on sensitive keys. Blue Chip has agreed to a monetary settlement of \$1,500 in lieu of disciplinary action.

ORDER 2023-181 IN RE SETTLEMENT AGREEMENT CSI OPERATING COMPANY, LLC d/b/a CAESARS SOUTHERN INDIANA 23-CS-04

Order 2023-181 involved a settlement agreement with Ceasars Southern Indiana and includes one count. Caesars Southern Indiana violated the rules on sensitive keys. Caesars Southern Indiana has agreed to a monetary settlement of \$1,500 in lieu of disciplinary action.

ORDER 2023-182 IN RE SETTLEMENT AGREEMENT MAJESTIC STAR CASINO, LLC d/b/a HARD ROCK CASINO NORTHERN INDIANA 23-HR-03

Order 2023-182 involved a settlement agreement with Hard Rock Northern Indiana and includes three (3) counts. In count one, Hard Rock violated the rules and their internal control procedures for electronic gaming devices progressive jackpot transfers. In count two, Hard Rock violated the sensitive key rules. In count three, Hard Rock violated the rules and their internal control procedures for the Voluntary Exclusion Program. Hard Rock Northern Indiana has agreed to a monetary settlement of \$5,000 in lieu of disciplinary action.

ORDER 2023-183 IN RE SETTLEMENT AGREEMENT HOOSIER PARK, LLC d/b/a HARRAH'S HOOSIER PARK 23-HP-04

Order 2023-183 involved a settlement agreement with Harrah's Hoosier Park and includes one count. Harrah's Hoosier Park violated the rules for sensitive keys on multiple

occasions. Harrah's Hoosier Park has agreed to a monetary settlement of \$11,500 in lieu of disciplinary action.

ORDER 2023-184 IN RE SETTLEMENT AGREEMENT INDIANA GAMING COMPANY, LLC d/b/a HOLLYWOOD CASINO LAWRENCEBURG 23-HW-04

Order 2023-184 involved a settlement agreement with Hollywood Casino Lawrenceburg and includes two (2) counts. In count one, Hollywood violated the electronic gaming device progressive surveillance rules when an electronic gaming device was placed into service without dedicated coverage on the progressive. In count two, Hollywood violated the rules for sensitive keys. Hollywood has agreed to a monetary settlement of \$7,500 in lieu of disciplinary action.

ORDER 2023-185 IN RE SETTLEMENT AGREEMENT HORSESHOE HAMMOND, LLC 23-HH-04

Order 2023-185 involved a settlement agreement with Horseshoe Hammond and includes three (3) counts. In count one, Horseshoe Hammond violated the rules and their internal control procedures on sports wagering prohibited participants. In count two, Horseshoe Hammond violated the rules and their internal control procedures for the soft count room. In count three, Horseshoe Hammond violated the licensing rules when they failed to renew several occupational licensees in a timely manner. Horseshoe Hammond has agreed to a monetary settlement of \$32,250 in lieu of disciplinary action.

ORDER 2023-186 IN RE SETTLEMENT AGREEMENT CENTAUR ACQUISITION, LLC d/b/a HORSESHOE INDIANAPOLIS 23-HI-04

Order 2023-186 involved a settlement agreement with Horseshoe Indianapolis and includes five counts. In count one, Horseshoe Indianapolis violated the rules and their internal control procedures for the Poker Room when they failed to report required information, violated the calculations of taxes, including RG-1 requirements, failed to safeguard assets and had inaccurate accounting records, failed to issue numerous W-2G's and failed to provide a security escort for an even exchange. In count two, Horseshoe Indianapolis violated the rules for table inventory closers. In count three, Horseshoe Indianapolis violated the rules for playing cards. In count five, Horseshoe Indianapolis violated the rules for progressive electronic gaming devices when an electronic gaming device was set up incorrectly. Horseshoe Indianapolis has agreed to a monetary settlement of \$33,500 in lieu of disciplinary action.

ORDER 2023-187 IN RE SETTLEMENT AGREEMENT GAMING ENTERTAINMENT (INDIANA), LLC d/b/a RISING STAR CASINO RESORT 23-RR-04

Order 2023-187 is a settlement agreement with Rising Star and includes one count. Rising Star failed to notify surveillance of entry into a sensitive area and of the dealer toke collection. Rising Star has agreed to a monetary settlement of \$1,000 in lieu of disciplinary action.

Seminole Hard Rock Digital has agreed to a monetary settlement of \$3,000 in lieu of disciplinary action.

ORDER 2023-189 IN RE SETTLEMENT AGREEMENT POINTSBET INDIANA, LLC d/b/a POINTSBET 23-PB-03

Order 2023-189 involved a settlement agreement with PointsBet Indiana and includes one count. Pointsbet violated the rules for sports wagering prohibited participants. PointsBet has agreed to a monetary settlement of \$1,000.

ORDER 2023-190 IN RE SETTLEMENT AGREEMENT RUSH STREET INTERACTIVE IN, LLC d/b/a BETRIVERS 23-RS-02

Order 2023-190 is a settlement agreement with Rush Street Interactive d/b/a BetRivers and includes two counts. In count one, BetRivers violated the licensing rules when they failed to notify the Commission of a termination in a timely manner. In count two, BetRivers violated their internal control procedures for verifying component hash signatures. BetRivers has agreed to a monetary settlement of \$1,500 in lieu of disciplinary action.
