

**ORDER 2022-06**  
**AN ORDER OF THE INDIANA GAMING COMMISSION**  
**CONCERNING RENEWAL OF SUPPLIER'S LICENSES**

In accordance with Ind. Code art. 4-33, Ind. Code art. 4-35, and 68 Ind. Admin. Code § 2-2, the Indiana Gaming Commission ("Commission") previously issued supplier's licenses to: (1) Global Surveillance Associates; (2) IGT; (3) Halifax Security, Inc.; (4) Zuvid, LLC; (5) Acres Manufacturing; (6) Data Financial, Inc.; (7) Incredible Technologies, Inc.; (8) Tony DeLeon and Associates, Inc. d/b/a Playersoft Technologies; (9) Interblock Luxury Gaming Products, D.D.; (10) TCS John Huxley Europe, LTD.; (11) Genesis Gaming Solutions, Inc.; (12) GAN (UK) Limited; (13) Amelco UK Limited; (14) SportRadar Solutions; (15) SG Gaming, Inc.; (16) Patriot Gaming and Electronics, Inc.

A supplier's license is valid for a period of one year. Further, in accordance with Ind. Code § 4-33-7-8, a supplier's license must be renewed annually along with the payment of Seven Thousand Five Hundred Dollars (\$7,500.00) as an annual renewal fee. Each of these licensees has requested renewal and paid the required renewal fee. The Commission has determined that the above-named supplier licensees remain in substantial compliance with Ind. Code art. 4-33, Ind. Code art. 4-35, and Title 68 of the Indiana Administrative Code and are suitable to hold a supplier's license.

The Commission hereby **GRANTS** the renewal of the licenses of each of the following for a period of one year as specified below:


- 1) Global Surveillance Associates: valid October 1, 2020 through September 30, 2022;
- 2) IGT: valid January 25, 2022 through January 24, 2023;
- 3) Halifax Security, Inc.: valid February 24, 2022 through February 23, 2023;
- 4) Zuvid, LLC: valid February 23, 2022 through February 22, 2023;
- 5) Acres Manufacturing: valid February 26, 2022 through February 25, 2023;
- 6) Data Financial, Inc.: valid March 4, 2022 through March 3, 2023;
- 7) Incredible Technologies, Inc.: valid March 4, 2022 through March 3, 2023;
- 8) Tony DeLeon and Associates, Inc. d/b/a Playersoft Technologies: valid March 7, 2022 through March 6, 2023;
- 9) Interblock Luxury Gaming Products, D.D.: valid March 19, 2022 through March 18, 2023;
- 10) TCS John Huxley Europe, Ltd.: valid March 19, 2022 through March 18, 2023;
- 11) Genesis Gaming Solutions, Inc.: valid March 23, 2022 through March 22, 2023;
- 12) GAN (UK) Limited: valid March 23, 2022 through March 22, 2023;
- 13) Amelco UK Limited: valid March 23, 2022 through March 22, 2023;
- 14) SportRadar Solutions: valid March 23, 2022 through March 22, 2023;
- 15) SG Gaming, INC.: valid March 29, 2022 through March 28, 2023; and
- 16) Patriot Gaming and Electronics, Inc.: valid March 31, 2022 through March 30, 2023.


Each licensee must notify the Commission of its desire to be considered for subsequent license renewal at least thirty days before the expiration of the license.
