

**ORDER 2024-141**

**AN ORDER OF THE INDIANA GAMING COMMISSION PROSPECTIVELY RENEWING  
THE CASINO OWNER'S LICENSE AND APPROVING THE APPOINTMENT OF POWER OF  
ATTORNEY OF CDITH, LLC d/b/a TERRE HAUTE CASINO RESORT**

In accordance with Ind. Code art. 4-33 and Title 68 of the Indiana Administrative Code, the Indiana Gaming Commission ("Commission") issued a casino owner's license to CDITH, LLC d/b/a Terre Haute Casino Resort ("CDITH"), effective December 27, 2021. The Commission has renewed this license annually since inception, most recently on December 11, 2023, which renewed the license through December 20, 2024.

On October 30, 2024, CDITH requested renewal of its casino owner's license and submitted the required annual renewal payment in the amount of \$5,000.

On December 11, 2023, by Order 2023-168, the Commission approved a renewal of the written power of attorney identifying Mr. Austin Miller as trustee-in-waiting for CDITH. Order 2023-168 stated this approval would expire "upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of CDITH's casino owner's license; or (2) modifies or withdraws the approval" of Mr. Miller. On October 30, 2024, CDITH indicated in writing its desire to maintain Mr. Miller as its trustee-in-waiting.

**COMMISSION ACTION**

Pursuant to Ind. Code § 4-33-6-12, the Commission found that CDITH substantially complied with the requirements set forth in Ind. Code art. 4-33 and Title 68 of the Indiana Administrative Code; therefore, CDITH is suitable to hold a casino owner's license. The Commission **GRANTS** renewal of CDITH's casino owner's license for a period of one year subject to CDITH maintaining its casino gambling operation, riverboat, hotel, and pavilion in substantial compliance with all applicable state and local laws, including but not limited to, Commission regulations, resolutions, orders, and/or other directives relating to the casino owner's license or the lawful conduct or operation of gaming in Indiana. The renewal of the casino owner's license is valid for a period of one year from December 21, 2024, through December 20, 2025.

Furthermore, the Commission **APPROVES** the renewal of power of attorney identifying Mr. Austin Miller as trustee-in-waiting for CDITH. The renewal expires upon the effectiveness of a subsequent Commission order that either: (1) addresses the renewal of CDITH's casino owner's license; or (2) modifies or withdraws the approval of Mr. Miller as granted herein.

According to Ind. Code ch. 4-21.5-3, this Order is effective fifteen days after it is served.
