	2. If you wish to be licensed as both a boxing and bare-knuckle judge, you must indicate as such in the check boxes below. You are required by rule to submit the full license fee with the application.
	3. The following information is required to be submitted to be issued a judge license:
	 (A) Application for Initial Licensure or Renewal of Licensure as a Professional Judge. (B) Verifying documentation of any certification the applicant has obtained from any organization which certifies judges. *If this is a renewal application, only information that has not yet been submitted is required. (C) A clear photocopy of a current government issued photographic identification card (i.e. driver's license, passport), which affirms that the applicant is at least twenty-one (21) years of age. *not required for renewals (D) One (1) digital photograph of the applicant which shows head and shoulders only, without a hat, and in a natural pose. Please email the digital photograph to iac@igc.in.gov and include your name in the subject line. *not required for renewals
