First, I want to recognize a few individuals that have left the Commission, starting with Alex Dudley. Alex's last day with the Commission was earlier this month. Alex was a key member of the legal team of the IGC for five years, most recently serving as general counsel. Alex made countless contributions to the Commission during his tenure and will be greatly missed, but we are

And then on the enforcement side of the house, Chad Daggy was promoted to supervisor; and Brian Olehy was promoted to assistant director at Horseshoe Indianapolis.

CHAIRMAN HEERENS: Do we have any old business to come before the Commission?

None appearing, let's move on to new business.

First, we have license renewals. Attorney Chris Neal will now present Orders 2024-137 through Order 2024-144.

Chris.

You have before you first Order 2024-137. Pursuant to Indiana Code Section 4-33-7-8 and 68 IAC Section 2-2-8, a supplier's license must be renewed each year along with a payment of \$7500 renewal fee. Each of the following licensees has submitted a timely request for renewal along with the required payment. That includes Aristocrat Technologies, Incorporated; SB Tech Malta Limited; United Tote Gaming Services LLC; JCM American Corporation; and American Gaming & Electronics, Incorporated.

Approving Order 2024-137 would have the effect of renewing the license of each of the respective licensees for a period of one year.

And, Commissioners, next on the agenda you

have before you Orders 2024-138, 2024-139, 2024-140, 2024-141 regarding the renewal of CSI Operating Company LLC doing business as Caesars Southern Indiana; Aztar Indiana Gaming Company doing business as Bally's Evansville; Indiana Gaming Company LLC doing business as Hollywood; and CDITH LLC doing business as Terre Haute Casino, casinos owner's license renewals respectively, sorry.

Caesars Southern Indiana, Bally's
Evansville, Hollywood, and Terre Haute have all
filed the proper paperwork and paid the required
renewal fee.

Previously by Orders 2023-165, 2023-166, 2023-167, and 2023-168, the Commission had approved the written power of attorneys for Caesars Southern Indiana at Bally's Evansville, Hollywood, and Terre Haute respectively.

These approvals will expire upon the renewal of the casino owners' license, and for that reason all must request the renewal of the Commission's approval of the written power of attorney concurrently with the request for renewal or they must present the Commission with a new written power of attorney naming new

 trustee-in-waiting.

Caesars Southern Indiana, Bally's
Evansville, Hollywood, and Terre Haute have all
stated their intent to maintain their existing
trustees-in-waiting and have not presented the
Commission with any modifications to their power
of attorney.

Approving Orders 2024-138, 2024-139, 2024-140, 2024-141 would have the effect of renewing the license and approving the power of attorney for Caesars Southern Indiana, Bally's Evansville, Hollywood, and Terre Haute for a period of one year.

And next for certificate of authority renewals, you have before you Order 2024-142. Pursuant to Indiana Code 4-38-8-1, a certificate of authority must be renewed each year along with the payment of \$50,000 renewal fee. The following certificate holder has submitted a timely request for renewal along with the required payment: That would be Gaming Entertainment Indiana LLC doing business as Rising Star.

Approving Order 2024-142 would have the effect of renewing the certificate of the

 respective licensee for a period of one year.

And next you have before you Order 2024-143. Pursuant to Indiana Code 4-38-6-6, a vendor's license must be renewed each year along with a payment of a \$50,000 renewal fee, and the following licensee has submitted a timely request for renewal along with the required payment: That is Bally's Interactive doing business as Bally Bet.

Approving Order 2024-143 would have the effect of renewing the license of the respective licensee for a period of one year.

And finally, you have before you
Order 2024-144. Pursuant to Indiana Code Section
4-33-24-15, and 68 IAC 26-3-10, a Paid Fantasy
Sports operator license must be renewed each year
along with a payment of a \$5,000 renewal fee, and
the following licensee has submitted a timely
request for renewal along with that required
payment: That is Sleeper DFS LLC.

And approving Order 2024-144 would have the effect of renewing that Paid Fantasy Sports operator license for a period of one year.

Thank you.

The company and its key persons have submitted the required applications and received temporary licenses issued by the IGC. Commission staff conducted background and financial investigations on the company along with their substantial owners and key persons. Commission staff found

no material derogatory information that would 2 affect suitability of the applicants. Staff's 3 final reports have been provided in the confidential Commission meeting documents. 4 Approving Order 2024-145 will grant a 5 6 permanent supplier license to Bluberi Gaming USA, 7 subject to annual renewal. 8 I'm happy to answer any questions that you 9 may have. 10 CHAIRMAN HEERENS: Any questions from the 11 Commissioners? None appearing, is there a motion on 12 13 Order 2024-145? 14 MR. WILLIAMS: I'll make that motion. You also have before you Orders 2024-150 and 2024-151 granting permanent Paid Fantasy Sports gaming operator licenses to Side Prize LLC doing business as PrizePicks, and Sleeper DFS LLC.

All of the applicants submitted the required application and received temporary licenses issued by the IGC. Commission staff conducted background and financial investigations on each applicant. Commission staff found no material derogatory information that would affect the suitability of any of the applicants. Staff's final reports are included in the confidential

Commission meeting documents that were provided 2 to you. 3 Approving Orders 2024-146 through 2024-151 4 will grant a permanent license to the 5 above-mentioned applicants. 6 I'm happy to answer any questions you may 7 have. Orders 2024-152, 2024-153 concerning an ownership
transfer request for shares of American Gaming
Electronics, Incorporated, to be transferred to
five employees, and a restructuring and ownership
transfer request in which Surveillance Systems
Integration, Incorporated, would become a limited
liability company and partial ownership would
transfer to an individual.

Upon receiving the transfer request, the Commission completed a background and financial investigation, finding the transferees were substantially compliant with Indiana statutes and regulations and finding no derogatory information that would affect the transferees' suitability for holding an interest in those companies.

Approving Orders 2024-152 and 2024-153 would have the effect of approving the ownership transfers.

You have before you 19 settlement agreements concerning disciplinary action against licensed suppliers, casinos, and sports wagering operators.

Order 2024-154 is a settlement agreement with Ainsworth Game Technology wherein a supplier violated the rules for shipping electronic gaming devices.

Ainsworth agreed to a monetary settlement of \$1500.

Order 2024-155 is a settlement agreement with Aristocrat Technologies wherein the supplier violated the rules for shipping electronic gaming devices on three separate occasions.

 $\label{eq:Aristocrat} \mbox{ agreed to a monetary settlement} \\ \mbox{of $6,000.}$

Order 2024-156 is a settlement agreement

with Interblock Luxury Gaming Products LLC wherein the supplier violated the rules for the vendor log while performing work at Bally's Evansville.

Interblock agreed to a monetary settlement of \$1,500.

Order 2024-157 is a settlement agreement with LNW Gaming, Incorporated, doing business as Light & Wonder wherein the supplier violated the rules for shipping electronic gamin devices.

Light & Wonder agreed to a monetary settlement of \$1,500.

Order 2024-158 is a settlement agreement with Surveillance Systems Integration,
Incorporated, wherein the supplier failed to disclose and/or falsely stated the company's ownership interests on its initial application in September of 2019 and on subsequent renewal applications. The company failed to notify the Commission when it became aware of the inaccurate disclosure.

A substantial owner also failed to disclose or falsely stated his relationship to a trust on his initial application in 2019 and on his 2023 renewal application. The substantial owner also

 failed to notify the Commission when it became aware of the inaccurate disclosure.

A trustee also failed to apply or hold a Level 1 occupational license since 2019.

Surveillance Systems Integrations agreed to a monetary settlement of \$30,000, and within 30 days of approval of the settlement agreement, they need to update all inaccurate information in their licensing applications, update the most recent quarterly ownership report to accurately reflect the current ownership of the company, and the trustee must submit their fully completed Level 1 license application.

Order 2024-159 is a settlement agreement with Ameristar East Chicago and includes two counts.

Order 2024-160 is a settlement agreement with Bally's Evansville and includes four counts.

In Count I, Bally's failed to notify

 surveillance during the replenishment of two ticket redemption units.

In Count II, the casino allowed a minor to access the casino floor on two separate occasions.

On Count III, Bally's violated the rules for sensitive keys on three separate occasions.

In Count IV, Bally's violated the rules for the vendor \log .

Bally's Evansville agreed to a monetary settlement of \$8,000.

Order 2024-161 is a settlement agreement with Belterra Casino wherein the casino violated the progressive rules for electronic gaming devices and live gaming devices.

Belterra agreed to a monetary settlement of \$6,500.

Order 2024-162 is a settlement agreement with Blue Chip Casino wherein the casino violated the rules for live gaming device fills and credits.

Blue Chip agreed to a monetary settlement of \$6,000.

Order 2024-163 is a settlement agreement with Caesars Southern Indiana and includes three

 counts.

In Count I, the casino violated the rules for live gaming device fills on four separate occasions.

In Count II, the casino violated the rules for sensitive keys on two separate occasions.

 $\label{eq:continuous} \mbox{In Count III, the casino violated the rules} \\ \mbox{for the Voluntary Exclusion Program.}$

Caesars Southern Indiana agreed to a monetary settlement of \$9,500.

Order 2024-164 is a settlement with French Lick Resort Casino wherein the casino allowed a minor to access the casino floor on two separate occasions.

French Lick agreed to a monetary settlement of \$4,500.

Order 2024-165 is a settlement with Hard Rock Northern Indiana and includes two counts.

Harrah's Hoosier Park agreed to a monetary settlement of \$20,500 and the submission of a corrective action plan for Count I and on the ongoing sensitive key issues.

Order 2024-167 is a settlement agreement with Hollywood Lawrenceburg and includes two counts.

In Count I, Hollywood violated the rules for surveillance by failing to limit access to surveillance areas.

Hollywood agreed to a monetary settlement of \$4,500.

Order 2024-168 is a settlement agreement with Horseshoe Hammond wherein the casino violated the rules for playing cards.

 Horseshoe Hammond agreed to a monetary settlement of $\$1,500\,.$

Order 2024-169 is a settlement agreement with Horseshoe Indianapolis and includes five counts.

In Count II, the casino failed to notify surveillance prior to moving funds on the casino floor.

In Count III, the casino allowed a minor to obtain access to the casino floor on two separate occasions.

In Count IV, the casino violated electronic gaming device rules when six devices were found to be operating with revoked software.

Horseshoe Indianapolis agreed to a monetary settlement of \$18,500.

Rising Star agreed to a monetary settlement

of \$2,000.

Order 2024-171 is a settlement agreement with Terre Haute Casino Resort and includes two counts.

In Count I, the casino violated the rules for live gaming device fills and credits.

In Count II, the casino violated the rules for currency transaction reporting.

Terre Haute agreed to a monetary settlement of \$13,500.

Order 2024-172 is a settlement agreement with Caesars Race and Sportsbook Indianapolis wherein a sports wagering operator allowed a minor to access the sportsbook on two separate occasions.

Caesars Race and Sportsbook Indianapolis agreed to a monetary settlement of \$4,500.

Relevant details for each settlement agreement have been provided in your meeting materials. Each settlement agreement will also be available on the Commission's website following the meeting.
