Why Do We Need A Severe Weather Sheltering Plan?

The Bloomington-Monroe County Severe Weather Sheltering Plan (also known as winter contingency) provides a coordinated response to protect people experiencing homelessness in Monroe County from exposure-related injury or death during cold weather. This plan includes emergency shelter options, crisis services, outreach protocols, animal support resources and transportation options.

The plan is designed to support **all individuals and families in need**—including men, women, children, families, couples, people with pets, and veterans. It prioritizes **low-barrier, inclusive access to shelter and services** while integrating medical and behavioral health resources.

Our objectives:

- Prevent injury or death due to exposure to extreme cold.
- Provide low-barrier emergency shelter and services during inclement weather.
- Coordinate resources efficiently across government entities, nonprofits, and volunteers.
- Ensure timely communication to at-risk individuals and support networks.

Note: This plan describes the emergency response to extreme winter weather in Bloomington-Monroe County, the population & service hub for Region 10. Separate plans will be developed for Lawrence County and Morgan County.

Together, we will work to ensure that every person—regardless of circumstance—has access to safe shelter, compassionate care, and community support this winter.

Activation of White Flag Protocols

White flag protocols refer to our community response to homelessness during severe weather, particularly when temperatures drop to freezing or below. During these nights, we work to expand shelter availability for those in need – in some cases relaxing shelter restrictions or adding backup shelter – to provide everyone a safe, warm place to stay. Day centers will also be opened during these periods.

This plan will be in effect from November 1, 2025 to March 31, 2026. Winter contingency/white flag protocols will be activated when:

- Temperatures fall below 32°F (0°C), or
- Wind chills reach dangerous levels (below 20°F), or
- Snow/ice storm warnings are issued.

The Monroe County Emergency Management Department will be responsible for activating the plan. Jamie Neibel, Director of Emergency Management, will email the activation alert to a distribution list that includes all agencies listed in this document as well as Heading Home of South Central Indiana.

Plan Distribution, Communication & Training

This plan will be shared with:

- First responders
- Shelter providers
- Outreach teams
- Medical and behavioral health teams
- Relevant public, private and nonprofit entities
- Community volunteers and faith partners

A training session will be held in October to explain the activation process and address any outstanding issues.

BSWERS Pet Policy

- At BSWERS sites that allow pets (First Christian and First United Methodist), the following rules apply:
 - Guests with pets are admitted only by permission of a Staff Person or Shift Leader. Permission may be revoked at any time should shelter staff become concerned the pet is becoming fearful, aggressive, disruptive or the situation is in any way unsafe.

- Pets should be up to date on recommended vaccinations before being brought onto Host Site property
- All pets must be on a leash or inside an animal crate/cARRIER at all times while on Host Site property.
- All pets must sleep inside an animal crate/cARRIER. The shelter has a few crates for animals no more than 30 inches long and weighing no more than 30 pounds. Guests with larger animals should seek shelter at Friends Place.
- Service Animals are welcome to the BSWERS as required by the Americans with Disabilities Act (ADA). “Emotional Support” and “Providing companionship” are not recognized as a “service” for purposes of the ADA. Guests with service animals will be asked the following two questions:
 - Is the dog a service animal required because of a disability?
 - What work or task has the dog been trained to perform?

TRANSPORTATION

Our goal is to provide transportation for people to reach emergency shelter with minimal exposure to severe weather.

On a trial basis, Bloomington Transit has offered to provide transportation from downtown to Wheeler Mission or Friend's Place. They can do this with at least a 12-hour notice during periods when Monroe County Emergency Management has declared a white flag night.

The STRIDE Mobile Crisis Team provides transportation to shelters as needed.

BEDFORD MEN'S WARMING SHELTER

Only one overnight emergency shelter for men is operating in Lawrence County: The Bedford Men's Warming Shelter. This agency serves as the hub for overnight emergency winter sheltering efforts as well as a daytime warming center for all, including women, couples and families.

- No residency requirements
- Low barrier - no background check or sobriety requirement
- Well-behaved pets welcome

Becky's Place serves women and children experiencing homelessness, but does not typically provide overnight emergency shelter. However, during severe winter weather they will offer the following accommodations:

- Using a family room for single women if they receive more calls from them than from families, allowing Becky's Place to house 3–5 women instead of one family.
- Welcoming women and children indoors to warm up, providing meals or food, and offering a couch or fold-out bed when extra space is needed.
- Providing gas cards (when available) to those sleeping in cars so they can stay warm, as well as distributing blankets or coats when they have extras.
- Contacting other shelters and resources to connect people with safe options if Becky's Place is unable to provide shelter directly.
