AREA OF POTENTIAL EFFECTS (Pursuant to 36 CFR Section 800.4(a)(1))

The APE for the history/architecture survey consists of the project area and adjacent parcels that have the potential for visual effects from the proposed project. This distance was chosen to ensure all buildings and structures 50-years and older that are visible to the project area were included in this report.

The proposed undertaking, limited to the intersection improvement, and the nature of the surrounding rural and agricultural landscape relegated the APE to just those resources situated adjacent to SR 37 at Cuba/Thimlar Road, and at Notestine Road.

The APE for the archaeology survey includes all existing, new and temporary Right-of-Way. This 12.2 hectare (ha) (30.1 acre (ac)) area extends between 10.0 and 195.0 meters (m) (33.0 and 640.0 feet (ft)) south of Notestine Road, along a 775.0-m (2,542.0-ft) westward stretch from that road's intersection with Thimlar Road. Running northeast along SR 37 from its Notestine Road intersection for 880.0 m (2,887.1 ft), the survey area extends on either side of SR 37 between 7.0 and 95.0 m (23.0 and 312.0 ft). 3.1 hectares (ha) (7.7 acres (ac)) of new right-of-way was initially anticipated.

The amended APE for the Phase 1a archaeological field reconnaissance includes seven additional areas. The additional area totals 0.2 hectares (ha) (0.5 acres (ac)) and breaks into seven sections. The Right-of-Way increased from 3.0 to 6.0 m (10.0 to 20.0 ft) wide.

ELIGIBILITY DETERMINATIONS (Pursuant to 36 CFR 800.4(c)(2))

One property is eligible for listing in the National Register of Historic Places (NRHP) within the APE. The house, located at 16029 SR 37 (IHSSI 003-245-01032), is eligible under Criterion C for Architecture as an excellent example of a Neo-Eclectic, French Provincial style, a style that is unique for Allen County. It has had minor alterations, including a replacement garage door on the south façade and a replacement entry door but retains integrity of location, design, setting, materials, and workmanship.

FF CT FINDING

The house at 16029 SR 37 (IHSSI 003-24 -01032)— "No Adverse Eff ct"

The Indiana Department of Transportation (INDOT), acting on behalf of the Federal Highway Administration (FHWA), has determined a "No Adverse Effect" finding is appropriate for this undertaking. INDOT respectfully requests the Indiana State Historic Preservation Officer provide written concurrence with the Section 106 determination of effect.

SECTION 4(F) COMPLIANCE REQUIREMENTS (for historic properties)

The house at 16029 SR 37 (IHSSI 003-245-01032)—This undertaking will not convert property from the house at 16029 SR 37 (IHSSI 003-245-01032), a Section 4(f) historic property, to a transportation use; INDOT, acting on FHWA's behalf, has determined the appropriate Section 106 finding is "No Adverse Effect"; therefore, no Section 4(f) evaluation is required for the house at 16029 SR 37 (IHSSI 003-245-01032).

SR 37 Intersection Improvements at Cuba/Thimlar Road, and Notestine Road Allen County, Indiana DES. NO.: 1900142

1. DESCRIPTION OF THE UNDERTAKING

The Indiana Department of Transportation (INDOT), with funding from the Federal Highway Administration (FHWA) proposes a project to improve intersections at SR 37 and Notestine Road and at SR 37 and Cuba/Thimlar Roads in Allen County, Indiana, Des. No. 1900142 (Appendix A: Maps).

The proposed project is in Cuba, Springfield, and Milan townships, as shown on the Grabill, Indiana 7.5-minute series United States Geological Survey (USGS) topographic quadrangle. The project lies in Sections 31 and 32, Township 32N, Range 14E, and in Section 3, Township 31N, Range 14E (Appendix: Maps). The Notestine Road intersection has a significant skew causing sight distance issues. Both intersections have a higher-than-expected crash frequency based on crash volume and facility characteristics. The purpose of this project is to improve safety of these intersections and improve traffic flow on SR 37. The proposed improvements for the intersection of SR 37 at Cuba/Thimlar Road would widen SR 37 to include the addition of left turn lanes onto Cuba Road and Thimlar Road. The intersection of SR 37 and Notestine Road would be re-aligned to the south, approximately 360 feet to eliminate the skew of the intersection. A total of 8.21 acres of permanent Right-Of-Way (ROW) will be needed for this project.

The APE is defined as the "geographic area or areas within which an undertaking may directly or indirectly cause alterations in the character or use of historic properties. The APE is influenced by the scale and nature of an undertaking..." (36 C.F.R. 800.16 [d]). The APE for the history/architecture survey consists of the project area and adjacent parcels that have the potential for visual effects from the proposed project. This distance was chosen to ensure all buildings 50-years and older that are visible to the project area were included in this report. A map of the aboveground APE is provided in Appendix A.

The archaeological survey area extended between 10.0 and 195.0 m (33.0 and 640.0 ft) south of Notestine Road, along a 775.0-m (2,542.0-ft) westward stretch from that road's intersection with Thimlar Road. Running northeast along SR 37 from its Notestine Road intersection for 880.0 m (2,887.1 ft), the survey area extends on either side of SR 37 between 7.0 and 95.0 m (23.0 and 312.0 ft) (Appendix A: Maps). The total survey area included 12.2 ha (30.2 ac). The proposed undertaking, limited to the intersection improvements, and the nature of the surrounding rural and agricultural landscape relegated the belowground APE to just those resources situated adjacent to SR 37 and its intersections with Notestine and Cuba/Thimlar Roads.

2. EFFORTS TO IDENTIFY HISTORIC PROPERTIES

On April 22, 2022, an early coordination letter (ECL) with an invitation to join in consultation for this project was sent to the following:

- Allen County Highway Department
- Stephanie Wagner: Historian, Allen County Genealogical Society of Indiana
- ARCH, Inc.

The ECL directed interested parties to access the ECL on INDOT's online document portal, INSCOPE (https://erms12c.indot.in.gov/section106documents/). A paper copy of the ECL was mailed to the Indiana SHPO as a designated consulting party for review and comment on the same day (Appendix B: Consulting Parties and Appendix C: Correspondence).

On April 22, 2022, INDOT distributed the invitation to join in consultation to the following Tribes (Appendix C: Correspondence):

- Eastern Shawnee Tribe of Oklahoma
- Miami Tribe of Oklahoma
- Peoria Tribe of Indians of Oklahoma
- Pokagon Band of Potawatomi Indians
- Shawnee Tribe
- Absentee Shawnee Tribe of Oklahoma
- Delaware Tribe of Indians
- Forest County Potawatomi Community
- Wyandotte Nation

Pursuant to 36 CFR § 800.4(b) Gray & Pape architectural historians used mapping of the project area provided by HNTB, who were the lead project designers, and the Indiana State Historic Architectural and Archaeological Research Database (SHAARD) of the Division of Historic Preservation and Archaeology (DHPA) to identify previously surveyed resources. SHAARD includes a database of previously surveyed above-ground resources, including data from the Indiana Historic Sites and Structures Inventory (IHSSI), the National Register of Historic Places (NRHP) inventory, the 2009 INDOT-sponsored Historic Bridge Inventory (HBI), and the Indiana Cemetery and Burial Ground Registry. Historical map research located the following maps for analysis: the 1875 Map of Allen County, Indiana (Morrison 1875); the 1898 Standard Atlas of Allen County, Indiana (Ogle 1898); the 1910 United States Postal Service (USPS) Map of Allen County, Indiana (USPS 1910); the 1935 map of Allen County, Indiana (Gottschalk 1935); and the 1958, 1981, and 1992 7.5-minute Grabill, Indiana quadrangles (USGS 1958, 1981; 1992) (See Appendix A: Maps).

On April 25, 2022, the THPO for the Forest County Potawatomi Community (FCPC) responded to the ECL and stated that if any "human remains, or archaeological materials are exposed the Tribe must be included with the SHPO in any consultation" (Appendix C: Correspondence).

On April 26, 2022, the Director of Cultural Preservation for the Peoria Tribe of Indians of Oklahoma responded to the ECL and stated that if any "items are discovered which fall under the protection of NAGPRA, the Peoria Tribe requests immediate notification and consultation" (Appendix C: Correspondence).

On April 27, 2022, the Indiana SHPO responded to the ECL and suggested the addition of Thomas E. Castaldi, Allen County Historian, and Paul Hayden, Director of Indiana Landmarks Northeast Field Office, as consulting parties. The SHPO also asked to be included in further regular correspondence on the project as well as being notified of which consulting parties have accepted (Appendix C: Correspondence).

On April 27, 2022, the THPO for the Miami Tribe of Oklahoma responded to the ECL offering no objection and that they are "not currently aware of existing documentation directly linking a specific Miami cultural or historic site to the project site" and requested to be involved immediately in consultation if any "human remains or Native American Cultural items falling under NAGPRA are discovered" (Appendix C: Correspondence).

On May 5, 2022, the Northeastern Indiana Regional Coordinating Council responded to the ECL and gave information on a series of SHAARD resources, pipelines, and potential obstructions located within the project area including: Two pipelines intersecting or near the project area, a leaking underground storage tank, five previously surveyed resources, and a drainage ditch (Appendix C: Correspondence).

On May 18, 2022, the THPO for the Eastern Shawnee Tribe of Oklahoma responded to the ECL and stated "We find our people occupied these areas historically and/or prehistorically. However, the project proposes NO adverse effects or endangerment to known sites of interest to the Eastern Shawnee Tribe." The tribe also requested to be contacted immediately if archaeological sites or objects were discovered (Appendix C: Correspondence).

Following the literature review, on May 18, 2022, Gray & Pape architectural historians conducted field reconnaissance of the APE and photographed all architectural resources within the APE that were already or that would be 50-years of age by the project's proposed September 2023 letting. Field documentation included photographs of the primary and secondary facades, when accessible; ownership information; resource style or type; and integrity considerations. Dates of construction for the historic architectural resources were established through a review of the Allen County Auditor property records, structural forms, and analyses of building materials (Appendix D: Photographs).

On May 20, 2022, the THPO for the Pokagon Band of Potawatomi Indians responded to the ECL and stated that "the proposed work is occurring within a mile of known archaeological sites, or features that are considered sensitive or recorded in the Pokagon Band Historic Inventory Database" The THPO further stated that "The project will have no adverse effects on any historic, religious, or culturally significant resources to the Pokagon Band of Potawatomi Indians" (Appendix C: Correspondence).

Gray & Pape archaeologists conducted a Phase Ia records check and field reconnaissance between May 30, and June 1, 2022. The records check identified no previously recorded sites in the survey area. The field survey located three previously unrecorded archaeological sites (Appendix E: Report Summaries).

The Phase Ia archaeology survey report was submitted to the State Historic Preservation Office on September 23, 2022 (Appendix C: Correspondence). On October 4, 2022, the Phase Ia archaeology survey report was sent to all potential Tribal consulting parties. The report recommended that no further archaeological investigations were necessary and that the project proceed as planned (Appendix C: Correspondence and Appendix E: Report Summaries).

On October 24, 2022, Indiana SHPO responded to the Phase la archaeological field reconnaissance survey report submittal. SHPO agreed that the portions of archaeological sites 12AL2335, 12AL2336, and 12AL2337 which work is required. SHPO also stated that the portions of archaeological sites 12AL2335, 12AL2336, and 12AL2337 that the portions of archaeological sites 12AL2335, 12AL2336, and 12AL2337 that the portions of the sites must be avoided, if avoidance is not possible, additional archaeological investigation is required prior to project construction. The letter also mentioned that if any other archaeological artifacts or human remains are discovered, they should be reported to SHPO within two business days (Appendix C: Correspondence and Appendix E: Report Summaries).

On November 17, 2022, the THPO for the Eastern Shawnee Tribe of Oklahoma responded to the Phase Ia Archaeological survey report and stated "We find our people occupied these areas historically and/or prehistorically. However, the project proposes NO adverse effect or endangerment to known sites of interest to the Eastern Shawnee Tribe." The tribe also requested to be contacted immediately if archaeological sites or objects were discovered (Appendix C: Correspondence).

The Shawnee responded on December 13, 2022, concurring that no known historic properties will be negatively impacted by this project. However, if archaeological materials are found during construction, the Shawnee requested to be re-notified for consultation (Appendix C: Correspondence).

Gray & Pape's architectural historians prepared a Historic Property Report (HPR). Fifteen contributing resources were identified within the APE with one resource (IHSSI 003-245-01032), recommended as eligible for listing in the NRHP.

Consulting parties were notified of the availability of the HPR on February 2, 2023, and provided directions to access it and the transmittal letter on INDOT's online document portal INSCOPE (at https://erms12c.indot.in.gov/section106documents/). In addition, paper copies of the documents were sent to the Indiana SHPO as a designated consulting party for review and comment on the same day. INDOT was copied on the correspondence (Appendix C: Correspondence and Appendix E: Report Summaries).

In addition, paper copies of the documents were sent to Justin D. and Jennifer Jean Krohn, as owners of the property at 16029 SR 37, for review and comment the next day.

On February 23, 2023, as suggested by the Indiana SHPO, an email was distributed to Thomas E. Castaldi, Allen County Historian, and Paul Hayden, Director of Indiana Landmarks Northeast Field Office, inviting them to join in the Section 106 process as consulting parties and informing them that an HPR had been prepared and was ready for their review. Both parties were also invited to access and review the ECL as well and given instructions on using INSCOPE (Appendix C: Correspondence). The request from SHPO to include these potential consulting parties was initially overlooked when their letter was received.

On March 1, 2023, SHPO responded to the submittal of the Historic Property Report (HPR). SHPO stated that the APE is of adequate size and agreed that there are no previously recorded properties listed or eligible for inclusion in the NRHP in the project area. They agreed that the house at 16029 SR 37 (IHSSI 003-245-01032) is eligible for listing on the NRHP. They also agreed that the remaining properties surveyed within the APE are ineligible for inclusion in the NRHP (Appendix C: Correspondence).

On March 13, 2023, the Eastern Shawnee Tribe of Oklahoma stated that the project proposes NO Adverse Effect or endangerment to known sites of interest to the Eastern Shawnee Tribe (Appendix C: Correspondence).

The Shawnee Tribe also concurred that that no known historic properties will be negatively impacted in an email dated March 29, 2023 (Appendix C: Correspondence).

On March 30, 2023, Thomas E. Castaldi and Paul Hayden were again invited to serve as consulting parties (Appendix C: Correspondence).

In June 2023, project designers identified additional areas where ROW will be acquired from the residential lot at the southwest quadrant of the intersection of State Road 37 and Thimlar Road (15840 SR 37) to accommodate shoulder widening. The entire lot will be purchased for the project. The additional project area totaled 0.2 hectares (0.5 acres).

The planned letting date was pushed to 2024. No additional above-ground resources will be 50 years or older by the revised letting date, so no additional above-ground analysis is required.

Gray and Pape archaeologists conducted field reconnaissance on September 24–25, 2023. The records check identified no previously recorded sites in the survey area. The field survey located one previously unrecorded archaeological site (Appendix E: Report Summary).

The Addendum Phase Ia archaeology survey report will be submitted concurrently with this document to the State Historic Preservation Office and relevant tribal organizations. The report recommended that no further archaeological investigations were necessary and that the project proceed as planned (Appendix E: Report Summaries).

No further comments were received on the project.

3. DESCRIBE AFFECTED HISTORIC PROPERTIES

The house at 16029 SR 37 is a two-story Neo-Eclectic French Provincial residential building, constructed ca. 1953. The front-facing, L-shaped building features a steeply pitched gable roof, clad in asphalt shingles, with shed and gable dormers of various sizes. A tower is in the space where the gables connect on the south façade. The building is clad in limestone. It is eligible for the NRHP under Criterion C as an excellent example of Neo-Eclectic French Provincial style.

4. DESCRIBE THE UNDERTAKING'S EFFECTS ON HISTORIC PROPERTIES

Construction for the proposed project will end approximately 85 m (280 ft) west of the historic property at 16029 SR 37. The mill and overlay at the eastern end of the project will be visible, but the turn lanes proposed at Thimlar Road will not be readily visible from the property. In addition, the stone wall and mature trees will partially block the construction activities from the property.

There are no plans to purchase permanent or temporary ROW from the property. As currently designed, the undertaking will have no direct effect on the eligible resource including the exterior features such as the pool house, driveway, and limestone fencing.

5. EXPLAIN APPLICATION OF CRITERIA OF ADVERSE EFFECT -- INCLUDE CONDITIONS OR FUTURE ACTIONS TO AVOID, MINIMIZE OR MITIGATE ADVERSE EFFECTS

As described in 36 CFR 800.5(a)(1), the criteria of adverse effect have been applied to this undertaking. An adverse effect is found when an undertaking may alter, directly or indirectly, any of the characteristics of a historic property that qualify that property for inclusion in the NRHP in a manner that would diminish the integrity of the property's location, design, setting, materials, workmanship, feeling or association.

Per 36 CFR 800.5 (a) (2), examples of adverse effects may include, but are not limited to the following:

- (i) Physical destruction of or damage to all or part of the property;
- (ii) Alteration of a property, including restoration, rehabilitation, repair, maintenance, stabilization hazardous material remediation and provision of handicapped access, that is not consistent with the Secretary's Standards for the Treatment of Historic Properties (36 CFR Part 68) and applicable guidelines;
- (iii) Removal of the property from its historic location;
- (iv) Change of the character of the property's use or of physical features within the property's setting that contribute to its historic significance;
- (v) Introduction of visual, atmospheric or audible elements that diminish the integrity of the property's significant historic features;
- (vi) Neglect of a property which causes its deterioration, except where such
 neglect and deterioration are recognized qualities of a property of religious and
 cultural significance to an Indian tribe or Native Hawaiian organization; and

 (vii) Transfer, lease, or sale of property out of Federal ownership or control without adequate and legally enforceable restrictions or conditions to ensure long-term preservation of the property's historic significance.

Application of the criteria of adverse effect defined in 36 CFR § 800.5(a), finds the proposed project's potential effects on the house at 16029 SR 37 (IHSSI 003-245-01032) are not likely to be described in 36 CFR § 800.5(a)(2) (iii), (vi), or (vii). The application of adverse effect, focusing on 36 CFR § 800.5(a)(2)(i) (ii), (iv), and (v) follows:

Per 36 CFR § 800.5(a)(i), no part of this property will be damaged by the project.

Per 36 CFR § 800.5(a)(ii), the property will not be altered by the project.

Per 36 CFR § 800.5(a)(iv), the property's use will not change, the overall rural, agricultural setting will not be significantly diminished.

Per 36 CFR § 800.5(a)(v), the project will resurface the pavement near the property, however; the resurfacing will not widen the roadway. This visual change is minor and will not diminish the integrity of features within the property.

Changes in the property's settings will not significantly reduce the rural feeling and will not interfere with the property's ability to convey its significance in architecture under Criterion C.

6. SUMMARY OF CONSULTING PARTIES AND PUBLIC VIEWS

Early Coordination Letters were sent to potential consulting parties on April 22, 2022.

On April 25, 2022, the Forest County Potawatomi Community agreed to be a consulting party.

On April 26, 2022, the Peoria Tribe of Indians of Oklahoma agreed to be a consulting party.

SHPO responded to the Early Coordination Letter on April 27, 2022, asking for additional parties to be added.

The Miami Tribe of Oklahoma confirmed their acceptance as a consulting party on April 27, 2022.

On May 5, 2022, the Northeastern Indiana Regional Coordinating Council responded and gave information on a series of potentially historic and other resources.

The Eastern Shawnee Tribe of Oklahoma Historic Preservation Department responded on May 18, 2022, agreeing to be a consulting party.

On May 20, 2022, the THPO for the Pokagon Band of Potawatomi Indians agreed to be a consulting party.

The Phase Ia archaeological survey report was submitted to consulting parties on September 23, and October 4, 2022.

In a letter dated October 24, 2022, Indiana SHPO responded agreeing that the portions of archaeological sites 12AL2335, 12AL2336, and 12AL2337 which particles and no further archaeological work is required. SHPO also stated that the portions of archaeological sites 12AL2335, 12AL2336, and 12AL2337 that have not been evaluated for inclusion in the NRHP.

On November 17, 2022, the THPO for the Eastern Shawnee Tribe of Oklahoma responded to the Phase Ia Archaeological survey report and stated "We find our people occupied these areas historically and/or prehistorically. However, the project proposes NO adverse effect or endangerment to known sites of interest to the Eastern Shawnee Tribe." The tribe also requested to be contacted immediately if archaeological sites or objects were discovered.

The Shawnee responded on December 13, 2022, concurring that no known historic properties will be negatively impacted by this project. However, if archaeological materials are found during construction, the Shawnee requested to be re-notified for consultation.

The historic property report was sent to consulting parties on February 2, 2023. Fifteen contributing resources were identified within the APE with one property, house at 16029 SR 37 (IHSSI 003-245-01032) being recommended as eligible for listing in the NRHP.

Justin D. and Jennifer Jean Krohn, the co-owners of the property located at 16029 SR 37, were sent hard copies of the HPR on February 3, 2023, and invited to become consulting parties.

On February 23, 2023, as suggested by the Indiana SHPO, an email was distributed to Thomas E. Castaldi, Allen County Historian, and Paul Hayden, Director of Indiana Landmarks Northeast Field Office, inviting them to join in the Section 106 process as consulting parties. The request from SHPO to include these potential consulting parties was initially overlooked when their letter was received.

In a letter dated March 1, 2023, SHPO responded to the submittal of the Historic Property Report. SHPO agreed that the house at 16029 SR 37 (IHSSI 003- 245-01032) is eligible for listing on the NRHP.

On March 13, 2023, the Eastern Shawnee Tribe of Oklahoma stated that the project proposes NO Adverse Effect or endangerment to known sites of interest to the Eastern Shawnee Tribe.

The Shawnee Tribe also concurred that that no known historic properties will be negatively impacted in a letter dated March 29, 2023.

An additional letter was created on March 29, 2023, and submitted, March 30, to again invite the Allen County Historian and Indiana Landmarks, Northeast Field Office to

participate as consulting parties.

Gray and Pape archaeologists conducted additional field reconnaissance on September 24–25, 2023. The field survey located one previously unrecorded archaeological site.

The Addendum Phase Ia archaeology survey report will be submitted concurrently with this document to the State Historic Preservation Office and relevant tribal organizations. The report recommended that no further archaeological investigations were necessary and that the project proceed as planned (Appendix E: Report Summaries).

No further comments were received from invited consulting parties.

A public notice of "No Adverse Effect" will be posted in the East Allen Courier, and the public will be afforded thirty (30) days to respond. If appropriate, this document will be revised after the expiration date of the public comment period.

Cuba Road intersects on the west side of SR 37 and Thimler Road intersects from the east side of SR 37. The SR 37 and Notestine Road intersection is also a two way stop with preferentiality given to SR 37. The Notestine intersection has a significant skew causing sight distance issues. Both intersections have a higher-than-expected crash frequency based on crash volume and facility characteristics. This letter is part of the Section 106 review process for this project. We are requesting comments from you regarding the possible effects of this project. Please use the above Des. The proposed undertaking is on SR 37 at Cuba/Thimlar Road, 5.00 miles east of I-469, and Notestine Road, 4.68 miles east of I-469, in Milan and Springfield Townships, shown on the Grabill 7.5 USGS Topographic Quadrangle, in Sections 31 and 32, Township 32N, Range 14E, and Section 3, Township 31N, Range 14E. The project area can be viewed online at https://arcg.is/jqueP (the Des. No. is the most efficient search term once in the CRO - Public Web Map App).

This section of SR 37 is a two-lane Major Collector. The SR 37 and Cuba/Thimlar Road intersection is a two-way stop with preferentiality given to SR 37. Cuba Road intersects on the west side of SR 37 and Thimlar Road intersects from the east side of SR 37. The SR 37 and Notestine Road intersection is also a two-way stop with preferentiality given to SR 37. The Notestine intersection has a significant skew causing sight distance issues.

From 2013 to 2017, there were 28 reported crashes at the intersection of SR 37 and Cuba/Thimlar Road. From 2009 to 2018, there were 36 reported crashes at the intersection of SR 37 and Notestine Road. For both intersections, the leading cause of crashes was failure to yield to the right-of-way followed by following too

closely. The intersection skew at SR 37 and Notestine Road is a geometric feature that could be attributable to these crashes.

As a result of the high number of crashes, a crash analysis was performed as part of the project development process for the intersection of SR 37 at Cuba/Thimlar Road and the intersection of SR 37 and Notestine Road. The Index of Crash Frequency (ICF) measures the difference between expected and reported number of crashes divided by the standard deviation of the difference in the estimate. The Index of Crash Cost (ICC) measures the difference between expected and reported crash costs. The ICC is used to consider the severity of crashes. These indices indicate whether the frequency or severity of crashes, respectively, are higher than would be expected based on the traffic volumes and facility characteristics. The index value for a specific location indicates how many standard deviations higher or lower the observed crash rate is than the expected crash rate. For example, an ICF or ICC value of 2.0 indicates that the observed crash frequency or severity at a specific location is two standard deviations higher than the expected value for the given type of facility and traffic volumes and can therefore be considered a high crash location.

Both intersections have a higher-than-expected crash frequency based on crash volume and facility characteristics. At SR 37 and Cuba/Thimlar Road, the Index of ICF and Index of ICC were 3.36 and 1.57, respectively. For SR 37 and Notestine Road, the ICF and ICC were 2.61 and 1.97, respectively.

The purpose of this project is to improve safety of these intersections and reduce the ICF and ICC to 1.0 or lower at each intersection.

The proposed improvements for the intersection of SR 37 at Cuba/Thimlar Road would widen SR 37 to include the addition of left turn lanes onto Cuba Road and Thimlar Road. The intersection of SR 37 and Notestine Road would be re-aligned to the south, approximately 360 feet to eliminate the skew of the intersection.

Pursuant to Section 106 of the National Historic Preservation Act of 1966, as amended (54 U.S.C. § 306108), 36 C.F.R. Part 800, and the "Programmatic Agreement (PA) Among the Federal Highway Administration, the Indiana Department of Transportation, the Advisory Council on Historic Preservation and the Indiana State Historic Preservation Officer Regarding the Implementation of the Federal Aid Highway Program In the State of Indiana," the staff of the Indiana State Historic Preservation Officer ("Indiana SHPO") has reviewed your January 30, 2023 submission which enclosed the historic property report ("HPR"; Carpenter, 1/30/2023), received by our office on February 2. 2023, for this project in Milan & Springfield Townships, Allen County, Indiana.

The area of potential effects ("APE") proposed in the HPR appears to be of adequate size to encompass the geographic area in which direct and indirect effects of a project of this nature could occur.

For the purposes of the Section 106 review of this federal undertaking, we agree with the conclusions in the HPR that there are no previously recorded National Register of Historic Places ("NRHP")-listed or -eligible resources located within the APE.

Regarding the House at 16029 SR 37 (IHSSI 003-245-01032), we agree with the conclusion of the HPR that this property is eligible for listing on the NRHP. We agree with the HPR that the house is an excellent representative example of a Neo-Eclectic, French Provincial style one that is unique for Allen County. Additionally, we concur with the HPR that the building retains integrity of location, design, setting, materials, and workmanship.

Furthermore, for the purposes of this Section 106 review for this federal undertaking, we agree with the conclusions in the HPR regarding the ineligibility of the remaining properties surveyed within the APE for inclusion in the NRHP.

Additionally, as previously indicated, based upon the submitted information and the documentation available to the staff of the Indiana SHPO, there is insufficient information regarding archaeological sites 12AL2335, 12AL2336, and 12Al2337—all of which were identified during the archaeological investigations—to determine whether they are eligible for inclusion in the National Register of Historic Places ("NRHP"). However, the portions of these sites that lie within the proposed project area do not appear to contain significant archaeological deposits, and we concur with the opinion of the archaeologist, as expressed in the Phase Ia archaeological field reconnaissance survey report (Connolly, 09/16/2022), that no further archaeological investigations appear necessary at this proposed project area. The portions of archaeological sites 12AL2335, 12AL2336, and 12Al233 7that lie outside the proposed project area must either be avoided or subjected to further archaeological investigations.

Additionally, those areas of the site should be clearly marked so that they are avoided by all ground-disturbing project activities. If avoidance is not feasible, then a plan for subsurface archaeological investigations must be submitted to the division of Historic Preservation and Archaeology ("DHPA") for review and comment. Any further archaeological investigations must be done in accordance with the "Secretary of the Interior's Standards and guidelines for Archeology and Historic Preservation" (48 F.R. 44716).

If any prehistoric or historic archaeological artifacts or human remains are uncovered during construction, demolition, or earthmoving activities, state law (Indiana Code 14-21-1-27 and Indiana Code 14-21-1-29) requires that the discovery be reported to the Indiana Department of Natural Resources, Division of Historic Preservation and Archaeology within two (2) business days. In that event, please call (317) 232-1646. Be advised that adherence to Indiana Code 14-21-1-27 and Indiana Code 14-21-1-29 does not obviate the need to adhere to applicable federal statutes and regulations, including but not limited to 36 C.F.R. Part 800.

The Indiana Department of Transportation (INDOT), with funding from the Federal Highway Administration (FHWA), proposes to proceed with a project involving the intersections at SR 37 and Notestine Road and at SR 37 and Cuba/Thimlar Roads in Allen County, Indiana, Des. No. 1900142.

This letter is part of the Section 106 review process for this project. Section 106 of the National Historic Preservation Act requires federal agencies to take into account the effects of their undertakings on historic properties. We are requesting comments from you regarding the possible effects of this project. Please use the above Des. Number and project description in your reply and your comments will be incorporated into the formal environmental study.

A Section 106 early coordination letter was distributed on April 22, 2022, and the Phase Ia archaeology report was submitted on September 27, 2022.

The proposed undertaking is on SR 37 at Cuba/Thimlar Road, 5.00 miles east of I-469, and Notestine Road, 4.68 miles east of I-469, in Milan and Springfield Townships, shown on the Grabill 7.5 USGS Topographic Quadrangle, in Sections 31 and 32, Township 32N, Range 14E, and Section 3, Township 31N, Range 14E. The project area can be viewed online at https://arcg.is/jqueP (the Des. No. is the most efficient search term once in the CRO - Public Web Map App).

This section of SR 37 is a two-lane Major Collector. The SR 37 and Cuba/Thimlar Road intersection is a twoway stop with preferentiality given to SR 37. Cuba Road intersects on the west side of SR 37 and Thimlar Road intersects from the east side of SR 37. The SR 37 and Notestine Road intersection is also a two-way stop with preferentiality given to SR 37. The Notestine intersection has a significant skew causing sight distance issues.

From 2013 to 2017, there were 28 reported crashes at the intersection of SR 37 and Cuba/Thimlar Road. From 2009 to 2018, there were 36 reported crashes at the intersection of SR 37 and Notestine Road. For both intersections, the leading cause of crashes was failure to yield to the right-of-way followed by following too

closely. The intersection skew at SR 37 and Notestine Road is a geometric feature that could be attributable to these crashes.

As a result of the high number of crashes, a crash analysis was performed as part of the project development process for the intersection of SR 37 at Cuba/Thimlar Road and the intersection of SR 37 and Notestine Road. The Index of Crash Frequency (ICF) measures the difference between expected and reported number of crashes divided by the standard deviation of the difference in the estimate. The Index of Crash Cost (ICC) measures the difference between expected and reported crash costs. The ICC is used to consider the severity of crashes. These indices indicate whether the frequency or severity of crashes, respectively, are higher than would be expected based on the traffic volumes and facility characteristics. The index value for a specific location indicates how many standard deviations higher or lower the observed crash rate is than the expected crash rate. For example, an ICF or ICC value of 2.0 indicates that the observed crash frequency or severity at a specific location is two standard deviations higher than the expected value for the given type of facility and traffic volumes and can therefore be considered a high crash location.

In terms of archaeological resources within the additional portions of the proposed project area, based upon the submitted information and the documentation available to the staff of the Indiana SHPO, there is insufficient information regarding archaeological site 12-Al-2349—which was identified during the additional archaeological investigations—to determine whether it is eligible for inclusion in the National Register of Historic Places ("NRHP"). However, the portions of this site that lie within the proposed project area do not appear to contain significant archaeological deposits, and we concur with the opinion of the archaeologist, as expressed in the (Addendum) Phase Ia Archaeological Field Reconnaissance Survey Report (Braunschweig and Moffatt, 03/28/2024), that no further archaeological investigations appear necessary at the additional portions of the proposed project area. The portions of archaeological site 12-Al-2349 that lie outside the proposed project area must either be avoided or subjected to further archaeological investigations. Pursuant to Section 106 of the National Historic Preservation Act of 1966, as amended (54 U.S.C. § 306108), 36 C.F.R. Part 800, and the "Programmatic Agreement (PA) Among the Federal Highway Administration, the Indiana Department of Transportation, the Advisory Council on Historic Preservation and the Indiana State Historic Preservation Officer Regarding the Implementation of the Federal Aid Highway Program In the State of Indiana," the staff of the Indiana State Historic Preservation Officer ("Indiana SHPO") has reviewed your submission, which we received via digital attachments to your May 20, 2024, e-mail message to our office, and which included your May 20, 2024, Review Request Submittal Form, and the Indiana Department of Transportation's finding of "no adverse effect," on behalf of the Federal Highway Administration for the project at the intersection of SR 37 and Cuba/Thimler Road in Milan Township and Springfield Township, Allen County, Indiana.

As previously stated, the area of potential effects ("APE") proposed in the HPR appears to be of adequate size to encompass the geographic area in which direct and indirect effects of a project of this nature could occur.

Additionally, we previously stated, for the purposes of the Section 106 review of this federal undertaking, we agree with the conclusions in the HPR that there are no previously recorded National Register of Historic Places ("NRHP")-listed or -eligible resources located within the APE. Regarding the House at 16029 SR 37 (IHSSI 003-245-01032), we agree with the conclusion of the HPR that this property is eligible for listing on the NRHP. Furthermore, for the purposes of this Section 106 review for this federal undertaking, we agreed with the conclusions in the HPR regarding the ineligibility of the remaining properties surveyed within the APE for inclusion in the NRHP.
