## LEGAL NOTICE PLANNED IMPROVEMENT

The Indiana Department of Transportation (INDOT) has developed preliminary plans for a proposed State Road (SR) 140 bridge replacement over Big Blue River, 0.68 mile south of US 40, located in Rush and Henry Counties (DES 2002071). The limits of the project extend from 378 feet north of the north corner of CR 1200 N to 922 feet south of CR 1200 N. The project proposes to replace the bridge with a 3-span continuous composite prestressed bulb-tee beam bridge and rebuild the approaches. The project also includes, but is not limited to, replacing the guardrails, scour protection in Big Blue Creek, relocating a small tributary on the southeast side of the bridge 15 feet east of its current location, correcting roadside slopes, and reshaping roadside ditches.

The maintenance of traffic plan for this project involves closing the road to traffic and using a detour consisting of US 40, SR 3, CR 900 and Rushville Rd. Access to all properties will be maintained throughout construction. Project stakeholders including local school corporation(s) and emergency services will be notified of potential closures and/or detours prior to any construction.

Construction of the project will require approximately 1.15 acres of new permanent right-of-way with an estimated total project cost of \$5,920,000. No temporary right-of-way will be needed. Evey effort to avoid, minimize, and/or mitigate project impacts will be made. The permanent right-of-way impacts will be approximately 0.38 acre in the northwest quadrant, 0.35 acre in the southwest quadrant, 0.20 acre in the northeast quadrant, and 0.22 acre in the southeast quadrant of the project area. The permanent ROW will be used to replace the structure, correct sideslopes and reshape ditches, place riprap, and clear the channel. Federal and states funds are to be utilized for the construction of the project.

The Federal Highway Administration and INDOT have agreed that this project falls within the guidelines of a Categorical Exclusion (CE) Level 3 environmental document with no significant impacts to wetlands. It is anticipated that 0.91 acre of trees will be removed during this project. The US Fish and Wildlife Service made a "likely to adversely affect" the Indiana bat (*Myotis sodalis*) and/or the northern long-eared bat (*Myotis septentrionalis*) effect determination. Erosion protection will be placed at the bases of the piers of the bridge. There is an unnamed tributary (UNT) to Big Blue River, on the southeast side of the bridge. Seven feet of the UNT will be realigned for bank stabilization at the confluence with Big Blue River changing the length of the UNT from 317 feet to 310 feet. Proposed impacts have been minimized to the extent practicable and cannot be avoided due to construction access needs and worker safety.
