## LEGAL NOTICE OF PLANNED IMPROVEMENT

The Indiana Department of Transportation (INDOT) is developing plans for the proposed slide correction project (DES. # 2000131) along State Road (SR) 66, approximately 1.35 and 0.90 miles west of SR 70 Junction (Jct); from 1.42 miles to 1.28 miles and from 0.98 mile to 0.90 mile west of SR 70 Jct in Spencer County.

The purpose of this project is to prevent further damage to the roadway and to reduce maintenance needs in the area. The need for the project stems from two overhead slides occurring off the westbound shoulder of SR 66. Both slides are causing pavement distresses, primarily in the shoulder with potential to extend into the westbound travel lane.

The project proposes to correct the overhead slides occurring off the westbound shoulder of SR 66 by cutting back areas of failed materials and mitigating the embankment slide by installing non-gravity, cantilever soldier-pile and lagging retaining walls. Some areas of roadway will require full depth patching. The shoulder work will consist of patching as needed and the installation of a 4-foot aggregate shoulder along the westbound lanes in front of the lagging retaining walls. A 15-inch corrugated metal pipe (driveway culvert) located approximately 5 feet from the westbound travel lane at the western end of the slide located 1.35 miles west of SR 70 will be removed and replaced with in-kind.

The proposed construction of this project will require 1.56 acres of new permanent right-of-way and 0.35 acre of re-acquired right-of-way. Temporary right-of-way is not anticipated. No relocations or displacements will occur as a result of the project.

The maintenance of traffic (MOT) plan proposes a road closure of SR 66 for approximately ten months. An official state route detour utilizing US 231 and SR 70 will be used during construction. Local roads may be used by local traffic. Access to all properties will be maintained throughout construction. School corporations and emergency services will be notified of closures prior to construction. The proposed start of construction is February 2026.

The project will result in a total of 0.028 acre of wetland impacts and 1.15 acres of tree removal.

The cost associated with this bundled contract is approximately \$10,236,100 which includes preliminary engineering, right-of-way, construction with both federal and state funds anticipated to be used. The Federal Highway Administration (FHWA) and INDOT have agreed this project falls within the guidelines of a Categorical Exclusion (CE) Level 2 environmental document.
