Subject: State Byway Designation of Indiana's Historic Pathways

Dear Lieutenant Governor Davis:

Byways in Indiana are officially designated by order of the Commissioner of the Indiana Department of Transportation with the support of the Lieutenant Governor. Following a resolution passed by the Indiana General Assembly on March 14, 2002, considerable local discussion and effort, and an extensive application process that produced two drafts reviewed in detail by the Indiana Byway Review Committee, representatives of the proposed byway are positioned to take the next step.

The Indiana Byway Committee recommends that Indiana's Historic Pathways (IHP), essentially US 50 from Lawrenceburg to Vincennes and US 150 from Clarksville to Vincennes, be designated the state's newest byway. Based on the archaeological, cultural, historic, natural, recreational and scenic intrinsic qualities exhibited within the proposed byway corridors I favor designation of Indiana's Historic Pathways as a state byway. I ask for your concurrence.



## ORDER OF THE COMMISSIONER

## TO ALL WHOM IT MAY CONCERN, GREETINGS:

WHEREAS: March 14, 2002, the Senate of the General Assembly of the State of Indiana, with the House of Representatives concurring, resolved that Indiana's Historic Pathways merit recognition by the state for outstanding qualities;

WHEREAS: The Department of Transportation is urged to designate portions of certain highways under state jurisdiction as a State Byway to be known as "Indiana's Historic Pathways"; and

WHEREAS: The Indiana Department of Commerce, the Indiana Department of Natural Resources and the Indiana Department of Transportation have worked cooperatively to achieve this designation; Therefore,

### BE IT RESOLVED BY ORDER OF THE COMMISSIONER

SECTION 1. Beginning at the Indiana-Illinois border on US 50/US 150, proceeding east through Shoals, Indiana and continuing northeast on US 50 through Lawrenceburg, Indiana to the Indiana-Ohio border.

SECTION 2. From US 50/US 150 at Shoals, Indiana, proceeding southeast on US 150 into New Albany, Indiana, then proceeding east on local roads to the Falls of the Ohio State Park in Clarksville, Indiana.

SECTION 3. Appropriate signs shall be designed and installed in accordance with current standards as determined by the Department of Transportation.

In testimony whereof, and with concurrence of the Indiana Lieutenant Governor, I have hereunto set my hand and caused to be affixed the seal of the Indiana Department of Transportation this day of October, 2004.
