DES. # 1602260 LEGAL NOTICE OF PLANNED IMPROVEMENT

The Indiana Department of Transportation (INDOT) has developed preliminary plans for a small structure replace on State Road (SR) 3 over an unnamed tributary to Wyaloosing Creek, 16.17 miles north of SR 7, located in Decatur County. The project proposes the replacement of the existing structure with a new concrete box structure.

The maintenance of traffic plan is for this project to be phased, maintaining a single lane of traffic controlled using a temporary signal. Access to all properties will be maintained throughout construction. Project stakeholders including local school corporations and emergency services will be notified of potential closures and/or detours prior to any construction.

Construction of the project will require approximately 1.35 acres of permanent right-of-way with an estimated cost of \$895,425. Federal and state funds are to be utilized for the construction of the project.

The Federal Highway Administration and INDOT have agreed that this project falls within the guidelines of a Categorical Exclusion (CE) Level 2 environmental document with no significant impacts to wetlands.
