

TRANSPORTATION POLICY COMMITTEE Resolution Number 09-25-INDOT-TIP

A resolution approving an AMENDMENT to the SFY 2026-2030 TRANSPORTATION IMPROVEMENT PROGRAM, herein after referred to as the TIP, as requested by the Terre Haute Metropolitan Planning Organization.

WHEREAS, Terre Haute Area Metropolitan Planning Organization (THAMPO) as a subset of the Terre Haute Area Economic Development Corporation (THEDC) is the Metropolitan Planning Organization (MPO), designated by the Governor of Indiana, for the West Central Indiana Metropolitan Planning Area (MPA) pursuant to 23 CFR 450.310 (Designations); and

WHEREAS, the Indiana Department of Transportation has requested this amendment to utilize Federal Assistance funds for projects as attached on page 2 of this Resolution;

WHEREAS, A draft version of the *TIP/STIP Amendment and/or Modification Report* that list this proposed amendment was posted on the THAMPO website for a 10-day public comment from September 5th to September 15th, 2025 with no adverse public comments received; and

WHEREAS, A draft version of the TIP/STIP Amendment and/or Modification Report was submitted to the Indiana Interagency Consultation Group for Air Quality Conformity review on September 8th, 2025 with no comments received requiring additional NAAQS analysis and therefore projects listed in the attached TIP/STIP Amendment and/or Modification report are considered EXEMPT;

THEREFORE BE IT RESOLVED, The THAMPO Transportation Policy Committee, hereby approves the aforementioned amendment to the TIP, described in the attached *TIP/STIP Amendment and/or Modification Report*, dated August 1, 2025.

The above and foregoing resolution was hereby adopted this 16th day of September 2025 during the regular meeting of the THAMPO Transportation Policy Committee held in Terre Haute, IN.

The discussion at the safety meeting revolved around extending the raised median both north and south from the intersection with Hulman Street to make both Osborne Street and Idaho Street Right-In/Right Out. This would also allow for extending the Left Turn on both the Northbound and Southbound US 41 approach to Hulman thereby removing vehicles waiting on Left Turn arrow from the through travel lane during green cycle. This is especially important on the SB approach as it immediately after the downhill crest that impacts visibility.
