

BACKGROUND AND REQUEST:

While reviewing the local project quarterly reports, it became apparent that the construction funding shown in the FY 2026 TIP was incorrect for Tippecanoe County's Bridge #64 and #65 projects. Looking back through various TIP reports and information, it appears that the incorrect funding amounts were used at the very early stage of development.

The correct funding information is shown in the previous FY 2024 TIP.

Through correspondence with INDOT Central Office, they asked that the corrections be made through a TIP amendment.

The following tables show the correct funding amounts.

BACKGROUND AND REQUEST:

The Indiana Department of Transportation requested an amendment to program two new projects.

The first project involves bridge maintenance work on two Hoosier Hartland bridges that are over the Norfolk Southern Railroad. There are issues with the MSE wall and fill material. Construction is targeted to begin early next calendar year.
