We have completed our review of INDOT's Amendment to the FY 2022-2026 Indiana Statewide Transportation Improvement Program (STIP) dated August 14, 2023. This amendment is for the inclusion of the following documents by reference:

- FY23-26 Kentuckiana Regional Planning and Development Agency (KIPDA) Transportation Improvement Program (TIP) (adopted May 25, 2023; conformity determination June 23, 2023)
- FY 23-26 KIPDA TIP Amendment 1
- FY 23-26 KIPDA TIP Amendment 2
- FY23-26 KIDPA TIP Modification 1
- FY23-26 KIPDA TIP Modification 2
- FY23-26 KIPDA TIP Modification 3

INDOT and KIPDA have re-demonstrated fiscal constraint, air quality conformity, and provided opportunity for public comment and involvement, where applicable, regarding the documents identified above. FHWA considers this amendment to be in substantial compliance with the applicable requirements as sufficient to support a consistency finding for the STIP.

FHWA only recognizes years 2022-2025 in the STIP. Any projects and/or phases of projects added in years outside of 2022-2025 are considered illustrative, and thus ineligible for federal funding at this time.
