WHEREAS,	the Delaware-Muncie Metropolitan Plan Commission (DMMPC) is the Metropolitan Planning
	Organization (MPO), as designated by the Governor of the State of Indiana, for the Muncie Urbanized
	Area; and

- WHEREAS, the Administrative Committee is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and
- WHEREAS, the Fiscal Year 2012-2015 Delaware Muncie Transportation Improvement Program (DMTIP) and FY 2014-2017 DMTIP were prepared as required multi-year programs of transportation improvement projects by jurisdictions within the Muncie Metropolitan Planning Area; and
- WHEREAS, the FY 2012-2015 DMTIP is in agreement with the 2009-2030 Delaware Muncie Transportation Plan, which was determined to conform with the Indiana State Implementation Plan (SIP); and
- WHEREAS, the FY 2014-2017 DMTIP is in agreement with the 2013-2040 Delaware Muncie Transportation Plan, which conforms with the Indiana State Implementation Plan (SIP); and
- WHEREAS, the FY 2012-2015 DMTIP and FY 2014-17 DMTIP needed to be amended to Project Des. #1383138 for construction to raise height and straighten beam bent in accident; and
- WHEREAS, the proposed DMTIP amendment to add said project was reviewed and approved by the Technical Advisory Committee by email vote on October 31, 2013; and
- WHEREAS, the same proposed amendment was reviewed and approved by the Administrative Committee by email vote on October 31-November 1, 2013.

NOW, THEREFORE, BE IT RESOLVED by the Administrative Committee of the DMMPC as follows:

Section 1. That the Fiscal Year 2012-2015 Delaware Muncie Transportation Improvement Program is amended to add Project Des. #1383138, Burlington Drive BR#18-5463 over US 35-Bypass, bridge rehabilitation and repair construction for \$40,016 in FY 2014 using \$32,013 in STP funds and \$8,003 in State funds.

Section 2. That the Fiscal Year 2014-2017 Delaware Muncie Transportation Improvement Program is amended to add Project Des. #1383138, Burlington Drive BR#18-5463 over US 35-Bypass, bridge rehabilitation and repair construction for \$40,016 in FY 2014 using \$32,013 in STP funds and \$8,003 in State funds.
