WHEREAS, the Transportation Policy Committee (TPC) is the policy committee of the Metropolitan Planning Organization involved in the transportation planning process for the Muncie Urbanized Area; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to add INDOT project DES #2301232, Various Raised Pavement Marking locations within Greenfield District (Safety), to add FY28 CN in the amounts of \$630,000 Federal HSIP funds and \$70,000 State matching funds was requested by INDOT; and

WHEREAS, the proposed amendment above was reviewed and approved by the TPC by e-vote concluding on February 13, 2026.

NOW, THEREFORE, BE IT RESOLVED by the Delaware Muncie Plan Commission (DMMPC) as follows:

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to add INDOT project DES #2301177, Various Locations in Delaware, Cass, & Howard County, Route 35 (11.35 miles) (Small Structures & Drains Construction) (Bridge), to add FY26 PE in the amounts of \$1,549,000 Federal STBG funds and \$387,000 State matching funds was requested by INDOT; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to add FY26 RW in the amounts of \$288,000 Federal STBG funds and \$72,000 State matching funds was requested by INDOT; and

WHEREAS, the proposed amendment to the FY 2026-2030 DMTIP to add FY28 CN in the amounts of \$5,299,000 Federal STBG funds and \$1,324,000 State matching funds was requested by INDOT; and

WHEREAS, the proposed amendment above was reviewed and approved by the TPC by e-vote concluding on February 23, 2026.

NOW, THEREFORE, BE IT RESOLVED by the Delaware Muncie Plan Commission (DMMPC) as follows:

Section 1. That the FY 2026-2030 DMTIP be amended to add INDOT DES #2301177, Various Locations in Delaware, Cass, & Howard County, Route 35(11.35 miles) (Small Structures & Drains Construction) (Bridge), to add FY26 PE in the amounts of \$1,549,000 Federal STBG funds and \$387,000 State matching funds as shown on the attached Exhibit A.




