

INDOT started an initiative in 2022 to purchase Limited Access Right of Way (LARW) near Interstate interchanges where there currently is inadequate coverage. The initiative aims to protect the safety and operation of the interchange terminal intersections by ensuring that access points from future developments on nearby properties are installed the proper distance away from the interchange.

I-69 at SR 332 (MM 241) in Delaware County is one of the interchanges that is being evaluated as a part of this initiative. Currently, the interchange only has LARW along SR 332 for roughly 100 feet west of the interchange and 430 feet east of the interchange. It is desirable to have between 600' and 1300' of LARW protection (See IDM 48-6E and 48-6F).

The project proposes to purchase LARW along SR 332 from where it currently ends for an additional 1100 feet on the west side of the interchange. LARW will also be purchased on the east side of the interchange in the northeast quadrant for approximately 790 feet. Two utility access points west of the interchange and the drive in the southwest quadrant will all remain open but with a minimal width of 20 feet. Lee Pit Rd will remain open. The three drives for the abandoned

gas station in the northeast quadrant will be closed and the property will be acquired. There is currently a turn lane for this property along EB SR 332. This turn lane would need to be hatched out with pavement markings. The agricultural drive east of the gas station will remain open with a minimal width of 20 feet. No LARW will be purchased in the southeast quadrant. All other access points within this distance will be removed as a part of the project and LARW fence will be installed.

Two abandoned gas station parcels will be acquired. All other impacted parcels will still have access to SR 332 or to another public road.
