Project Location:

The Federal Highway Administration (FHWA) and the Indiana Department of Transportation (INDOT), Crawfordsville District is proceeding with a federal aid bridge project along US 40 0.5 mile west of SR 75 in Jefferson Township, Putnam County, Indiana. The project involves Bridge No. 040-67-01838C (Des. No. 1601094), which carries US 40 over the Sallust Branch of Mill Creek.

Project Description:

The existing structure is a single-span reinforced concrete cast-in-place structure constructed in 1921. Additions were built on the structure in 1938. The bridge was determined eligible for the National Register of Historic Places (NRHP), per the INDOT Statewide Historic Bridge Inventory. The inventory also designated the structure as a "Select" bridge, meaning that it is a good candidate for preservation. The procedures outlined in Stipulation III.A of the Programmatic Agreement Regarding Management and Preservation of Indiana's Historic Bridge (Historic Bridges PA) have been followed. Per the Historic Bridges PA, a Purpose and Need statement and Alternatives Analysis were developed.

The bridge is listed in the *Indiana Historic Bridge Inventory* as a Select Bridge. This designation means it is suitable for preservation and considered eligible due to its significance as a "Crossing built to serve Main Market No. 3 and represents ISHC's early development to the state highway system and pre-World War II widening to serve as a U.S. Highway."¹ Designated as a Select Bridge also means the bridge must be preserved when using funds from the FHWA. Because the bridge is considered Select in status, the project must follow the conditions set forth in the *Historic Bridges Programmatic Agreement*. An Historic Bridge Alternatives Analysis (HBAA) was prepared by RQAW on July 9, 2019 and an addendum issued on April 21, 2020. In addition to the "Do Nothing" alternative, the HBAA evaluated an alternative that included the rehabilitation of the bridge for continued vehicular use meeting Secretary of Interior's Standards for rehabilitation. This alternative was advanced as the preferred alternative. A description of what this alternative involves follows.

The existing structure would be repaired, preserved and maintained for vehicular use in a way that does not adversely affect the bridge's historic features. Such activates include the structure's beams being patched and fiber-wrapped to strengthen deteriorated beams and prevent future deterioration. The substructure (abutments) and railing will also be patched with pneumatically placed mortar. Additionally, rip rap will be placed along the banks. In order to access the substructure for repairs and placing rip rap, a temporary haul road will be in the northeast quadrant of the bridge and a temporary cofferdam and pump around will be used.

Purpose and Need:

The need for the project is due to the deteriorated condition of the existing structure. If deterioration is allowed to continue on this structure, it will eventually lead to failure and not perpetuate a crossing on US 40 over Sallust Branch Mill Creek.

The purpose of this project is to provide a structurally sufficient and hydraulically adequate structure that perpetuates vehicular traffic crossing at this location.

Right-of-Way (ROW):

This project will occur within existing ROW. No permanent or temporary ROW will be required for this project.

Schedule:

- Public Comments Due: October 1, 2020
- Finalize Environmental Document: October 2020
- Finalize Design: 2020
- Contractor Award of Project (Letting): January 2021
- Construction Begins: Spring 2021

Cost:

The construction cost is estimated to be \$600,000.

Maintenance of Traffic (MOT):

The MOT for the project will require phased construction. Temporary lane closure and one lane traffic over East and West bound bridges will allow for continued use during construction. Access to properties within the project limits will be maintained at all times during construction. The MOT will be implemented per the Indiana Design Manual guidelines.
