Legal Notice of Public Hearing Des. No. 1601094

The Indiana Department of Transportation (INDOT) will host a public hearing on Thursday September 17, 2020, at the Stilesville Fire Station (8353 N Hendricks St., Stilesville, IN 46180), the hearing doors will open at 5:00 p.m. and the presentation begins at 5:30 p.m.

Social distancing guidelines will be followed. The capacity of the presentation is limited to 20 people to allow for social distancing. Project team members will wear face masks, chairs and project exhibits will be spaced six feet apart. Hand sanitizer will be available, and attendees are to wear face masks per the Governor's executive order.

In addition to the public hearing at the Stilesville Fire Station, INDOT is providing a virtual opportunity to watch the public hearing presentation live online. The purpose of the public hearing is to offer all interested persons an opportunity to comment on the Categorical Exclusion (CE) environmental document, the 800.11(e) documentation for Section 106, and current preliminary design plans for the proposed bridge project located on US 40 over Sallust Branch of Mill Creek in Putnam County, Indiana, approximately 0.5 mile west of SR 75. The purpose of the project is to continue providing the public with a structure that perpetuates vehicular crossing on US 40 over Sallust Branch of Mill Creek at current safety standards and requirements for at least 25 years with a structurally sufficient structure.

The project proposes to rehabilitate Bridge No. 040-67-01838C, NBI No. 013740. The preferred alternative proposes to repair, preserve, and maintain the existing structure for vehicular use in a way that does not adversely affect the historic features of the bridge. The proposed project includes patching and fiber-wrapping the deteriorated beams to prevent further deterioration, patching the remaining substructure (abutments and wing walls) and existing railing with pneumatically placed mortar, and placing riprap along the banks. The unsound concrete in the beams, abutments, and wing walls will be removed and replaced with new concrete.

The project will take place within existing INDOT right-of-way and will not require the purchase of permanent or temporary right-of-way. The maintenance of traffic (MOT) will involve temporary lane closures to allow US 40 to remain open during construction. Construction is anticipated to begin in July 2021.

The Bridge No. 040-67-01838C, NBI No. 013740 is eligible for the National Register of Historic Places (National Register). As part of the Indiana Historic Bridge Inventory project, the bridge was determined to be Select.

Section 106 of the National Historic Preservation Act (NHPA) requires Federal agencies to take into account the effects of their undertakings on historic properties. The proposed project does not involve

any properties eligible for the National Register aside from the subject bridge. This project will result in "no historic properties affected" under Section 106. The INDOT, on behalf of the FHWA will be issuing a "no historic properties affect" finding for the project. In accordance with the NHPA, the views of the public are being sought regarding the effect of the proposed project on the historic elements as per 36 CFR 800.2(d), 800.3(e) and 800.6(a)(4). Pursuant to 36 CFR 800.6(a) (4), the documentation of "no historic properties affected" specified in 36 CFR 800.11 (e) is available for inspection electronically by accessing INDOT's Section 106 document posting website IN SCOPE at http://erms.indot.in.gov/Section106Documents. The FHWA and the INDOT have agreed that this project falls within the guidelines of a Categorical Exclusion Level 4. At present, both state and federal funds are anticipated for construction of the project with the total cost estimated at approximately \$600,000. No significant adverse impacts to the human and natural environment were found during the creation of this document.
