Project Update

SR25 Hoosier Heartland
Tippecanoe, Carroll and Cass Counties
DES# 9802920

The Groundbreaking Ceremony for the SR25 Hoosier Heartland project took place on October 22, 2008 at the Faith Community Center in Lafayette. The first three contracts for this project have been awarded this year to meet Governor Daniels' accelerated schedule that was announced in February 2008.

The first contract was awarded to Walsh Construction on September 4, 2008. The limits of this contract are from just west of the Norfolk Southern Railroad to just east of the Tippecanoe/Carroll County line, and includes mainline construction of the new highway as well as twin bridges over the railroad and County Line Road.

On October 1, 2008, Milestone was awarded the CR1000E contract from just north of CR700N to just south of CR800N. This contract will bridge CR1000E over the new SR25 project.

Jack Isom Construction was awarded the third contract for this year on November 19 for CR625E from just north of CR400N to just south of CR450N. CR625E will be bridged over the new SR25 project and the Norfolk Southern Railroad.






