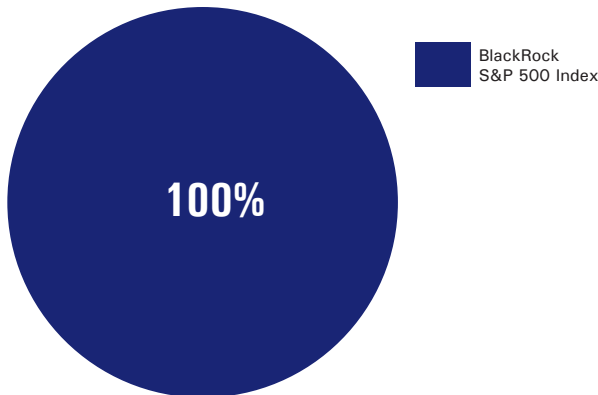
The Investment Objective of the Large Cap Equity Fund is to seek investment growth/capital appreciation through passive investment in the stocks of large-sized US companies.

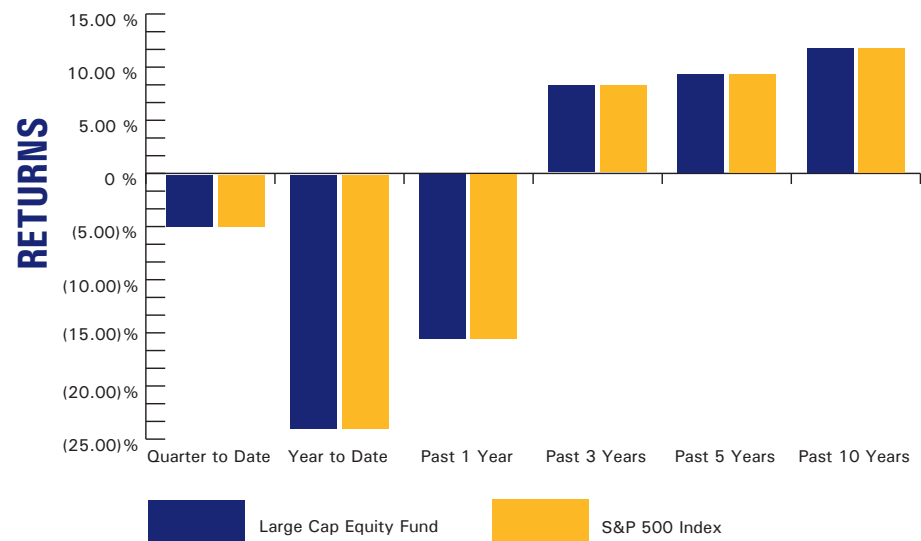
