# August-2011 CLEAN WATER INDIANA REPORT

## **Executive Summary:**

Administered by the State Soil Conservation Board (SSCB), the Clean Water Indiana (CWI) Grants Program is funded through the CWI Initiative. The purpose of the CWI Grants Program is to provide financial assistance to Soil and Water Conservation Districts (SWCDs) to implement conservation practices to reduce non-point sources of water pollution through education, technical assistance, training, and cost share programs.





## 2010 CWI GRANT


## PURPOSE OF GRANT:

For 2010, the State Soil Conservation Board (SSCB) designated \$550,000 for this grant cycle, as well as provided more choices for the use of grant funds. Each Soil and Water Conservation Districts (SWCDs) was given the opportunity to apply up to \$7,000. The focus for this round of grant funding includes:

- Adult Education
- Outreach/Marketing
- Cost Share Incentives
- Capacity Building
  - Staffing
  - Leadership Development Training

88 SWCDs applied for the 2010 CWI grant totaling \$583,409. The SSCB approved all grant applications and funded the total amount applied. All 2010 CWI grants have one year to complete their project, except for Leadership Development Training. Projects start January 1, 2010 and must be complete by December 31, 2010. Leadership Development Training reimbursement may include training from July 1, 2009 through December 31, 2010.





## STATUS UPDATE:

- 80 Districts have submitted a final report and final payment has been issued. \$559,219.04 has been paid. \$18,301.71 has been liquidated.
- Final Reports were due May 31. 2 counties have not submitted their final report. We are working with those districts (Ripley and Monroe) to get final reports submitted.
- The following counties have extensions on the 2010 grants: Hancock (10/31), Elkhart (9/30), LaPorte (9/30), and Tippecanoe (11/30), Lawrence (7/31)



- Multi-District Initiatives
- Capacity Building
  - Staffing
  - Leadership Development Training

88 SWCDs applied for the 2011 CWI grant totaling \$573,408. The SSCB approved all grant applications and funded the total amount applied. All 2011 CWI grants have one year to complete their project which starts January 1, 2011 and must be completed by December 31, 2011.

## **2011 CWI WATERSHED GRANT**


## **PURPOSE OF GRANT:**

For 2011, the State Soil Conservation Board (SSCB) awarded \$84,000 for competitive watershed-based grants. **Projects** are to fund one or more of the categories listed below:

- Cost Share/Incentives/Demonstrati
- Increase Direct Professional Assist

18 applications were received for the 2011 CWI grant totaling over \$500,000. The SSCB approved 5 grant applications and awarded a total of \$84,000.

## **Conservation Reserve Enhancement Program (CREP)**

## **August 2011 Report**

The Conservation Reserve Enhancement Program (CREP) is a federal-state natural resources conservation program that addresses agricultural-related environmental concerns at the state and national level. CREP participants receive financial incentives to voluntarily enroll in the Conservation Reserve Program (CRP) in contracts of 14 to 15 years. Participants remove cropland from agricultural production and convert the land to native grasses, trees and other vegetation.

The Indiana CREP is a partnership of the Indiana State Soil Conservation Board (SSCB), Soil and Water Conservation Districts (SWCD), Indiana State Department of Agriculture (ISDA), USDA Farm Service Agency (FSA), Natural Resource Conservation Service (NRCS), Indiana Department of Environmental Management (IDEM), Indiana Department of Natural Resources (DNR), and The Nature Conservancy (TNC). The program currently targets the enrollment of 26,250 acres of land in 11 watersheds where sediments, nutrients, pesticides and herbicides run off from agricultural land.

The program will improve water quality by creating buffers and wetlands that will reduce agricultural runoff into the targeted watersheds. Installing buffer practices and wetlands will enhance habitat for wildlife, including State and Federally-listed threatened and endangered species. The program will also reduce nonpoint source nutrient losses.



## **Additional CREP Information:**

## Lower East Fork White:

Approximately **176 acres** of CP-31 (Bottomland Timber Establishment) have been enrolled since January 2011. One landowner enrolled approximately 130 acres.

#### Lower Wabash:

CREP enrollment has been very successful. Six different landowners enrolled approximately **240 acres** of CP-31 (Bottomland Timber Establishment), ranging from 5 acres to 82 acres. In addition, one landowner is converting **21 acres** of cropland to CP-23 (Wetland Restoration within the floodplain).

## Lower White:

Approximately **20** acres of CP-2 (Permanent Native Grass) and **30** acres of CP-31 (Bottomland Timber Establishment) are in the hopper to be completed. Additional cropland may be converted to CP-2 (Native Grasses).

#### Middle Wabash Busseron:

Enrollment has been very active in this watershed. On July 7, Kenny Farrington, a farmer of Vermillion County, received a check for \$41,040. He converted 102.6 acres of cropland to CP-31 (Bottomland Timber Establishment). About 51,000 tree samplings were planted on Farrington's 102.6 acres. Dale Walker, resource specialist, presented the check to the farmer. The event was held at a gazebo overlooking the Wabash River near South Water Street and Elm Street in Clinton. It was attended by local media, Les Zimmerman (Vermillion County SWCD), Connie Brown (FSA), Bob Eddleman (SSCB), Bill Mann (SSCB), and Mike Carty (County Council of Vermillion County), among others.

In Vermillion and Sullivan counties, approximately **2 acres** of CP-22 (Riparian Buffer), **53 acres** of CP-2 (Native Grasses) and **100 acres** of CP-31 (Bottomland Timber Establishment) have been enrolled since December 2010. It is expected that some of the tree planting will take place in early 2012.

#### Middle Wabash Deer:

**6.6 acres** of CP-2 (Permanent Native Grass) and **12.7 acres** of CP-31 (Bottomland Timber Establishment) are in the hopper.

#### Middle Wabash Vermillion:

Approximately **20** acres of CP-31 (Bottomland Timber Establishment) have been enrolled since the expansion.

## Pigeon-Highland:

Since the expansion, approximately **2 acres** of CP-2 (Permanent Native Grass), **5 acres** of CP-22 (Riparian Buffer), and **11 acres** of CP-31 (Bottomland Timber Establishment) are in the hopper. A few acres have already been planted out.

## Tippecanoe:

No new agreements since the expansion.

## Upper East Fork White:

**23.5 acres** of CP31 (Bottomland Timber Establishment) and **33.4 acres** of CP-3A (Hardwood Tree Planting) are in the hopper.

## Upper Wabash:

Approximately 17 acres of CP31 (Bottomland Timber Establishment) and 1 acre of CP-4D are in process of completion.

## Upper White:

Since the expansion, 1 acre of CP2 ((Permanent Native Grass), 10.7 acres of CP-21 (Filter Strip), 12.4 acres of CP-22 (Riparian Buffer), and 10.9 acres of CP-31 (Bottomland Timber Establishment) are in various stages of completion.

## RECOMMENDATION FOR VACANT APPOINTMENT POSITION

#### APPOINTED SUPERVISOR, VACANCY: IC 14-32-13

Sec. 13 (a) If a vacancy in the position of appointed supervisor occurs during a district's operating year:

(1) the district supervisors shall, within thirty (30) days after the vacancy occurs, recommend to the board in writing one (1) or more individuals qualified to fill the position,

(2) at the first board meeting held after the board received a recommendation under subdivision (1), the board shall act upon the recommendation, and

(3) the board shall notify the supervisor of the appointment made by the board.

(b) The individual appointed to fill a vacant appointed supervisor position under subsection (a) shall serve the unexpired term of the individual's predecessor.

("Board" as used in the state statue refers to the State Soil Conservation Board)
