**“Is Your ED Ready for Children?
Pediatric Emergency Care Coordinators Lead the Way to Readiness!”**

Emergency care is an inherently chaotic environment generating underlying risk. Furthermore, pediatric emergency care is even more risky due to the infrequency of pediatric patient encounters and provider discomfort in providing pediatric care. The 2006 Institute of Medicine Report, *Future of Emergency Care, Growing Pains*,ⁱ recommends all hospitals have two pediatric emergency care coordinators (PECC), one of whom is a physician. Additionally, the American Academy of Pediatrics, the American College of Emergency Physicians, and the Emergency Nurse Association, via the 2009 Pediatric Emergency Care Guidelinesⁱⁱ also recommend the availability of physician/nurse PECCs in all emergency departments (ED) to support pediatric readiness.

In 2013, more than 4,100 hospitals participated in an assessment as part of the National Pediatric Readiness Project, a multi-phase quality improvement initiative to ensure that U.S. emergency departments have the essential guidelines and resources in place to provide effective emergency care to children. Analysis of assessment data validated that having PECCs in EDs increased the likelihood of emergency department readiness for children.ⁱⁱⁱ This webinar will share data supporting the need for PECCs, as well as strategies employed to identify and assure availability of PECCs in the EDs of a large hospital system. Finally, a physician and nurse PECC will discuss challenges encountered and opportunities to improve pediatric readiness in their ED.

and hospital regulators, health care planners, family members, trauma program coordinators and managers, and others interested in improving pediatric emergency care.
