





PRODUCT:** Deli Counter Products Containing Reser's Fine Foods (see attached list)

SUMMARY: Voluntary Recall; Following the Reser's Fine Foods, Inc. ("Reser's") recall where select Reser's products were recalled due to the potential of being contaminated with *Listeria monocytogenes*, Taylor Farms Tennessee, Inc. ("TFTN") and Taylor Farms Maryland, Inc. ("TFMD") are voluntarily recalling a limited number of products that contain Reser's recalled ingredients. There have been no reported illnesses associated with these products. The products subject to the recall were only served at the deli counters at the respective establishments listed below and are limited to the code dates provided.

See the attached list for detailed store and product information. The recalled products were shipped between October 19, 2013 and October 24, 2013. The grocers involved have been instructed to remove any remaining product from their deli case and to dispose of any of the remaining product in their inventory. No other products or code dates are affected by this recall. The recalled products were distributed in Tennessee, Florida, Alabama, Louisiana, Michigan, Ohio, Indiana, Illinois, Mississippi, Georgia, North Carolina, Kentucky, South Carolina, Delaware, Maryland, Pennsylvania, New Jersey, New York, Connecticut, Maine, Massachusetts, Rhode Island, New Hampshire, Virginia, and Vermont.

FOR IMMEDIATE RELEASE - October 25, 2013 - Following the Reser's Fine Foods, Inc. ("Reser's") recall where select Reser's products were recalled due to the potential of being contaminated with *Listeria monocytogenes*, Taylor Farms Tennessee, Inc. ("TFTN") and Taylor Farms Maryland, Inc. ("TFMD") are voluntarily recalling a limited number of products that contain Reser's recalled ingredients. There have been no reported illnesses associated with these products. The products subject to the recall were only served at the deli counters at the respective establishments listed below and are limited to the code dates provided. These products are being recalled because they have the potential to be contaminated with *Listeria monocytogenes*, an organism which can cause serious and sometimes fatal infections in young children, frail or elderly people, and others with weakened immune systems. Although healthy individuals may suffer only short-term symptoms such as high fever, severe headache, stiffness, nausea, abdominal pain and diarrhea, *Listeria* infection can cause miscarriages and stillbirths among pregnant women. To date, there have been no reported illnesses associated with these recalled items.
