<u>Inspection Code</u>	<u>Description</u>
41-1-4	There is debris in the bus. (needs cleaned/includes dirt)
51-1-1	Any door seals are missing, damaged, or torn
8-1-4	See Notes: Any defect inspector deems a violation not listed
63-1-7	The tires on dual wheels are touching
70-1-8	Any required reflective tape is applied in the wrong location, missing, and wrong width or badly faded
70-1-1	There is unapproved glazing material installed in the bus
70-1-7	Any emergency window is too difficult to open
82-1-2	See Notes: Any defect inspector deems a violation not listed
50-1-2	The seat belt cutter is not secured using a positive fastening method.
43-1-8	Any required lettering is missing or faded.
28-1-5	The bodily fluid kit (optional) does not contain 1 pair of rubber or plastic gloves, bleach or appropriate disinfectant (dry, chlorine absorbent, etc.), leak proof bags, soap and paper towels.

23-2-1	Exhaust leak exceeding one (1) inch measurable in any direction or half (1/2) inch in diameter.

Bus Type Description

Type A School Bus - A conversion or body constructed upon a van-type or cutaway front-section vehicle with a left side driver's door, designed for carrying more than ten (10) persons. The term includes two (2) classifications:

1. Type A-1, with a gross vehicle weight rating of ten thousand (10,000) pounds and under.
2. Type A-2, with a gross vehicle weight rating over ten thousand (10,000) pounds.
