<u>Inspection Code</u>	<u>Description</u>
37-1-1	The horn does not operate at all
29-1-5	Prohibited area sign is missing or obscured
45-1-1	Switch does not simultaneously disable interior noise-producing accessories such as radios or speakers, NOT including 2 way radios, defroster fans, passenger heater fans, powered roof ventilators, or any other noise- producing device. EXEMPTION Type A buses - OEM accessories not including two-way, AM/FM, Satellite, or similiar.
2-1-1	Required back-up lights do not function.
44-1-1	Any marker light or lens is missing, cracked, faded, wrong color, or inoperative
17-1-1	Any dome light is inoperative
64-1-4	Any front turn signal does not function properly
13-1-1	Any clearance light is missing, cracked, faded, wrong color, or inoperative
11-1-2	The front or rear bumper is not properly attached, missing, torn, loose, or altered.
70-1-7	Any emergency window is too difficult to open
23-1-6	Tailpipe does not extend to, or extends more than 1" beyond the perimeter of the bus body
41-1-2	Any interior protrusions have sharp edges or corners
41-1-4	There is debris in the bus. (needs cleaned/includes dirt)
57-1-5	Step-well light is missing or inoperative

Violations - Out of Service

<u>Inspection Code</u>	<u>Description</u>
34-2-2	Both lamps are inoperative on high beam
34-2-1	Both lamps are inoperative on low beam
64-2-1	Any rear turn signal does not function properly
62-2-1	Two (2) or more taillights or brake lights do not function (LED lights are considered non-functional if 50% or more pixels are inoperable in one light.)
69-2-1	Wipers fail to function
70-2-4	Audible warning device, when required, is not working properly. Buzzers are required after 5-2-94
70-2-1	Any glass or glazing is broken through or missing

Bus Type Description

Type A School Bus - A conversion or body constructed upon a van-type or cutaway front-section vehicle with a left side driver's door, designed for carrying more than ten (10) persons. The term includes two (2) classifications:

1. Type A-1, with a gross vehicle weight rating of ten thousand (10,000) pounds and under.
2. Type A-2, with a gross vehicle weight rating over ten thousand (10,000) pounds.
