## **Key Topics & Concepts**

#### Search & Seizure

- Fourth Amendment applies to searches and seizures.
- Plain view, protective sweep, and exigent circumstances are exceptions.

## **SECTION 2: TRAFFIC LAW**

## **Key Topics & Concepts**

## Operating While Intoxicated (OWI)

- OWI can occur from alcohol, drugs, or other impairing substances.
- Implied consent must be read when there is probable cause.
- Refusal to test may result in license suspension or a warrant for blood draw.

## **Enforcement on Private Property**

Reckless driving, leaving the scene, and OWI are enforceable.

## **Traffic Stops & Officer Conduct**

- Officer must be in uniform or clearly identified.
- Searches during seatbelt-only stops are restricted.

#### **Arrests & Probable Cause**

Warrantless misdemeanor arrest requires presence, with exceptions (e.g., OWI).

#### Vehicle Operation & Equipment

- Headlamps visible from 500 feet.
- Unauthorized red/blue lights = Class C misdemeanor.

#### **License Plates & Registration**

- Interim tags valid for 45 days.
- Homemade plates are illegal.
- Minimum license plate height: 12 inches.

### **Emergency Vehicles**

- Must yield to lights/sirens.
- Move Over Law' requires lane change or reduced speed.

## Sample Questions

Q: What must an officer have to conduct a traffic stop under Title 9?

• A: Must be in uniform or clearly identified.

Q: What is required when a vehicle is stopped for OWI and the driver refuses testing?

• A: May pursue a warrant, arrest, or file probable cause affidavit.

Q: What is the maximum speed allowed for a Motor Driven Cycle (Class B)?

• A: 35 mph.
