To provide healthcare and educational communities resources to aide in the recovery of unidentified or missing persons. There are over 1,000 missing persons in Indiana's Law Enforcement database. Together with hospitals, Vital Records, State Department of Health, Family and Social Services, and other agencies, we can greatly reduce the number of missing persons in Indiana.



Green Alerts

New Green Alert legislation takes effect July 1

Beginning July 1, 2024, Indiana will offer a new alert in the search for missing persons.

The Green Alert, adopted during the 2024 legislative session, allows for emphasis to be placed on missing veterans at risk defined by Indiana Code 12-7-2-197.3 as a veteran or active duty member of the armed forces of the United States, the national guard, or a reserve component of the armed forces of the United States, who is known, based on information provided by a person making a report under IC 12-10-18-1, to have a physical or mental health condition that is related to the veteran's military service.

Indiana Green Alerts will join the list of Indiana's established alerts which include: AMBER Alert, Silver Alert, and Blue Alert.

For consideration, an Alert must be recommended by the local law enforcement agency of jurisdiction and meet all criteria published on the Clearinghouse website.



Get Involved: CyberTipline

The National Center for Missing and Exploited Children (NCMEC) CyberTipline is the nation's centralized reporting system for the online exploitation of children. The public and electronic service providers can make reports of suspected online enticement of children for sexual acts, extra-familial child sexual molestation, child pornography, child sex tourism, child sex trafficking, unsolicited obscene materials sent to a child, misleading domain names, and misleading words or digital images on the internet.

NCMEC staff review each tip and work to find a potential location for the incident reported so that it may be made available to the appropriate law-enforcement agency for possible investigation. We also use the information from our CyberTipline reports to help shape our prevention and safety messages.

Indiana's Active Silver Alerts



STEVEN BRYAN is a 3-yearold white male, 3 feet 5 inches

tall, 32 pounds, with brown hair and blue eyes. He is believed to be with **CALEB BLEVINS**, a 30year-old white male, 6 feet tall, 225 pounds with brown hair and brown eyes.

The pair is missing from Mooresville, Indiana which is 18 miles southwest of Indianapolis and were last seen on July 20, 2022.

They may be in the company of Deborah Bryan, a 29-year-old white female, 5 feet 8 inches tall, 135 pounds with brown hair and hazel eyes, driving a Silver 2020 Toyota Rav4 with Indiana plate VSH490.

The bulletin is updated daily Monday through Friday with information from the National Crime Information Center (NCIC) and the Indiana Data and Communication System (IDACS). National Center for Missing and Exploited Children (NCMEC)

The mission of the National Center for Missing and Exploited Children is to help find missing children, reduce child sexual exploitation, and prevent child victimization. They operate a 24/7 national hotline (1-800-THE-LOST) for tips and reports related to missing and sexually exploited children, create and distribute missing child posters, redistribute AMBER Alerts, operate the CyberTipline for child sexual exploitation, help locate victims of child sex trafficking, assist law enforcement with tracking non-compliant sex offenders, provide crisis intervention and counseling referrals, and ensure that victims of child sex trafficking have access to the recovery services and support they need.

The Indiana General Assembly established the Indiana Clearinghouse for Information on Missing Children and Missing Endangered Adults in 2009. The Clearinghouse is intended to serve as the state central repository for all information on missing children and missing endangered adults from Indiana or believed to be in Indiana. The program is designed to collect, store, and disseminate information on missing children and missing and endangered adults. The Clearinghouse provides liaison among citizens, private organizations, and law enforcement agencies regarding missing children information.
