Dear Ms. Darlington:

Attached are the IURC tariff pages for the above FCC Transmittals. The proposed tariff revisions will mirror NECA's interstate access tariff filings that were submitted to the F.C.C. with no exceptions.

**Transmittal 1273** introduces a new optional volume discount plan for Ethernet Transport Service (ETS). This filing also modifies the rate structure for non-adjacent jointly provided ETS. Specifically, this filing introduces regulations and rates related to the use of ETS Interconnected Ethernet Virtual Connections. (ETS I-EVCs). ETS I-EVCs are used in conjunction with other applicable ETS rate elements when the distance between the ETS Serving Wire Centers (SWCs) serving the customer's designated premises (CDPs) is fifty airline miles or less. This filing also revises the existing rate structure for jointly provided, non-adjacent ETS to specify it will apply when the distance between the ETS SWCs serving the CDPs is greater than fifty airline miles. Lastly, this filing clarifies the minimum service period for an ETS Channel Termination is twelve months.

***(FCC Approval Date: 5/15/2010) Transmittal 1273 affects all TDS Telecom IN companies and any non-TDS Telecom companies that concur with CCI and this service. The service will be offered on both an interstate and intrastate basis.***

**Transmittal 1275** makes miscellaneous name changes and additions to the list of companies in the Title Pages, Optional Rate Plan Availability, Rates Tables, DSL Access Services Availability and Federal Universal Service Charge sections. In addition the filing removes the LNP End User Charges which have expired at some companies.

***(FCC Approval Date: 6/1/2010) Transmittal 1275 does not apply to CCI for Intrastate Access Services nor do they include any IN Companies concurring in CCI's intrastate access tariff.***

**Transmittal 1278** revises rates for interstate access service. Specifically, the filing revises End User Common Line, Federal Universal Service Charge and various switched and special access service rates. In addition, this filing reflects changes to the listings of companies participating in the tariff.


This filing also reflects the removal of the following companies from the common line, end user and/or traffic sensitive tariffs to implement their conversions to price cap regulation as recently authorized by the Commission.

Finally, this filing reflects the removal of several companies from Section 17.6 (DS) and 8.1.6(A)(2)(ADSL Exceptions, where applicable, as those companies have opted to offer wireline broadband Internet access transmission service on a detariffed, common carrier basis.

***(FCC Approval Date: 07/01/10) Transmittal 1278 affects all TDS Telecom IN companies and any non-TDS Telecom companies that concur with CCI and this service. The service rates are applicable on both an interstate and intrastate basis.***
