**LEGAL NOTICE**

Notice is hereby given that Wastewater One, LLC, Galena Wastewater Treatment Plant (the "Utility") has filed a request with the Indiana Utility Regulatory Commission (the "Commission") to increase certain non-recurring charges of the utility. The request is expected to be filed with the commission by January 10<sup>th</sup>, 2011. Approval of the filing is expected approximately thirty days after the filing. The purposed increases are for non-recurring charges and do not affect Utility usage rates.

**(A) CONNECTION CHARGE**

Each residential user at the time he is connected with sewage disposal system shall pay a charge to cover the costs of: locating the lateral; excavating; furnishing and installing the service pipe from the residence to the boundary line of the easement, public road or street under which such lateral may be located; backfilling; and restoring surface materials. The charge for such connection shall be three hundred dollars

**(B) FLATE RATE FOR SEWAGE DISPOSAL SERVICE**

Residence            **\$84.79** per month

**(C) DEFERRED PAYMENT CHARGE**

To all bills allowed to become delinquent, there shall be added a deferred payment charge, on the following basis:

10% of first \$3.00 and 3% of amounts over \$3.00 per month of any delinquent amount

**(D) Non Sufficient Funds Charge**

Any users who, upon payment of their account, submits a check that is subsequently dishonored by the bank shall be assessed a \$30.00 charge.

**(E) Initial Reconnection Charge with Installation of Cut-Off Valve**

Any users, who have been disconnected from service by actions or inactions of the user, where a cut-off valve has not been installed, will incur a charge of \$1,086 upon reconnection with installation of a cut-off valve. Subsequent reconnection fees will be \$100 per occurrence.
