

AMENDMENT #1
CONTRACT #000000000000000000041251

This is an Amendment to the Contract (the "Contract") entered into by and between the Indiana Utility Regulatory Commission (the "State") and Indiana Underground Plant Protection Service (the "Contractor") approved by the last State signatory on 4/26/2020.

In consideration of the mutual undertakings and covenants hereinafter set forth, the parties agree as follows:

1. The Contract is hereby extended for an additional period of one year. It shall terminate on October 30, 2021.
2. Total remuneration under the Contract is not to exceed \$37,500.00.
3. The Indianapolis Indians 2020 season was cancelled as a result of Covid-19. Within Exhibit A, all references to "2020" are hereby amended to read "2021".
4. The Contract is amended by adding the following:

No certified MBE or WBE subcontractors will be participating in this Contract during the extension period.

No certified IVOSB subcontractors will be participating in this Contract during the extension period.

Paragraph 4, "Term", is deleted in its entirety and replaced with the following: This Grant Agreement commences on March 1, 2021 and shall remain in effect through October 30, 2021. Unless otherwise provided herein, it may be extended upon written agreement of the parties, and as permitted by the state or federal law governing this Grant.

All matters set forth in the original Contract and not affected by this Amendment shall remain in full force and effect.

Non-Collusion and Acceptance

The undersigned attests, subject to the penalties for perjury, that the undersigned is the Contractor, or that the undersigned is the properly authorized representative, agent, member or officer of the Contractor. Further, to the undersigned's knowledge, neither the undersigned nor any other member, employee, representative, agent or officer of the Contractor, directly or indirectly, has entered into or been offered any sum of money or other consideration for the execution of this Contract other than that which appears upon the face hereof. **Furthermore, if the undersigned has knowledge that a state officer, employee, or special state appointee, as those terms are defined in IC § 4-2-6-1, has a financial interest in the Contract, the Contractor attests to compliance with the disclosure requirements in IC § 4-2-6-10.5.**

Agreement to Use Electronic Signatures
