

GENERAL ADMINISTRATIVE ORDER OF THE INDIANA UTILITY REGULATORY COMMISSION 2017-1

WHEREAS, in accordance with Indiana Code section 8-1-2-65, the Indiana Utility Regulatory Commission ("Commission") must keep a record of all its proceedings and formal investigations and "all testimony shall be taken down by the stenographer appointed by the [Commission]."

WHEREAS, the Commission employs two full time court reporters to meet the stenography statutory requirement and the court reporters' transcripts are received in evidence as a "true and correct transcript" of the proceedings pursuant to Indiana Code section 8-1-2-66.

WHEREAS, parties may request copies of transcripts and in accordance with Indiana Code sections 44-22-4-1(a) and 8-1-3-8, transcript fees are the property of the Commission court reporter who prepared the transcript.

WHEREAS, transcripts are "furnished on the terms fixed by the [Commission] to any party to such investigation" under Indiana Code section 8-1-2-67 and the Commission may set the cost of preparing transcripts through a general administrative order under Indiana Code section 8-1-3-8.

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the Schedule of Transcript Fees Pursuant to Indiana Code section 8-1-3-8, which is attached to the General Administrative Order as Appendix A, is adopted by this Commission, and GAO 1995-5 is hereby superseded.

APPENDIX A

Schedule of Transcript Fees Pursuant to Indiana Code section 8-1-3-8

I. Applicability

These fees apply to transcripts of records of proceedings before the Indiana Utility Regulatory Commission ("Commission") and documentation to perfect appeals, when prepared by the court reporters employed by the Commission. If the Commission utilizes contract court reporters, fees shall be set out in the contract.

II. Fees

For additional copies of an original transcript, per page	\$ 1.25	\$ 1.25
For producing all other documents necessary to constitute a complete record of proceedings for the purposes of perfecting an appeal to the Indiana Court of Appeals or Supreme Court of Indiana, including but not limited to pleadings, orders, certification, etc., per page	\$ 2.00	\$ 3.00
For mounting and incorporating exhibits and other documents and other services requested in connection with preparation of a complete records of the proceedings for purposes of perfecting an appeal to the Indiana Court of Appeals or Supreme Court of Indiana, including but not limited to pleadings, orders, certification, etc., per hour	\$ 15.00	\$ 15.00
For transcripts provided by midnight local time of a running record or a proceeding which occurred that day, per page	\$ 5.00	\$ 5.00
For transcripts of a record provided by the next business day, per page	\$ 4.30	\$ 4.30
For transcripts of a record provided within three (3) business days, per page	\$ 3.60	\$ 3.60

III. Requests from Indigent Parties

Pursuant to Indiana Code section 4-22-4-1(b), in cases of indigent parties, transcript fees shall be paid from the State of Indiana General Fund.
