

Public Notice of Required Communications Services Tariff Filings

pursuant to I.C. 8-1-2.6-1.5(d)

Notice requirements have recently changed for communications services tariff filings in Indiana, following the passage of Senate Enrolled Act 492, which was signed in 2013. The applicable portion of the statute reads, as follows: **"If the commission requires a provider to file a tariff for intrastate switched access service, special filing of the tariff with the commission serves as the public notice of the filing of the tariff. The commission shall provide the public with notice of tariff filing or other electronic means."** [S.E.A. 492 (2013), SECTION 5, *codified* at Ind. Code 8-1-2.6-1.5-6(d)]. This requirement became effective on July 1, 2013. Posting and filing fulfill the Commission's legal obligations under Ind. Code 8-1-2.6-1.5-6(d). No other notice is required by the Commission.
