Request: Request to implement a Green Power Rider to allow customers an option to designate a specific amount (from 100kWh up to 1000kWh in blocks of 100kWh) of their energy consumption to be attributable to energy generated from renewable and/or environmentally friendly sources. The surcharge will be \$1.00/100kWh.

Customer Impact: This is a voluntary program and will only affect those that choose to participate in the program.

Tariff Page(s) Affected: Crawfordsville new Green Power Rider.

Staff Recommendations: 170 IAC 6-1 et seq. allows for the use of the 30-Day Filing mechanism for rates and charges for new services. Crawfordsville's new Green Power Rider simply extends an offering from their wholesale power provider, Indiana Municipal Power Agency (IMPA), to retail customers. Crawfordsville passes through their wholesale charges (with a de minimis difference of \$0.001/kWh to cover administrative charges) for "Green Power" onto those retail customers that voluntarily select a portion of their electricity to be provided from these resources.

Staff's analysis shows this as a revenue-neutral offering of new service allowed for by the 30-Day mechanism and recommends approval.

Filing # 3367, a new (initial) intrastate switched and special access tariff (Tariff I.U.R.C. No. 6) filed by Communications Corporation of Indiana (CCI), a subsidiary of TDS Telecom, received temporary approval at the IURC conference on June 30, 2015, pursuant to IC 8-1-2-113 and as permitted under IC 8-1-2-42(a). The underlying tariff went into effect on July 1. With the instant request, staff is seeking final approval for CCI's initial intrastate access tariff, as originally filed on June 18.
