Charging Tariff ("EVFC")

Customer Impact: The EVFC rate is composed of two components: an energy charge and

a vehicle idling fee. The energy charge component is calculated using a statewide average for EVFC charging offered by individual fast charge stations in Indiana that charge a consumption-based or time-based fee, are greater than 50kW in charging output capacity, offer at least one charging connector and are publicly accessible 24-hours per day. This average rate is reviewed quarterly and updated when the statewide average changes by more than 10% from the amount listed

in this tariff.

In this filing, the proposed energy charge represents an increase of

17%.
