The utility is proposing to change its tap-in fee, reconnection fee, general service charge, general service surcharge and its insufficient funds charge. The changes are needed due to increased costs in labor, equipment and materials. Ramsey provided cost support for each of its proposed changes.

The following new miscellaneous item has been reviewed by staff members of the Commission and we recommend accepting it for filing.

1. Ramsey Water Company, Inc.
