ORDER OF THE COMMISSION

Request:

NIPSCO is proposing to revise Rider 677 – Economic Development Rider to include an option (at NIPSCO's sole discretion) to offer up to a 30% discount of the increased base rate charges in each of the 5 years customers are eligible to be included in this Rider instead of the current graduated option (50% the first year and decreasing by 10% in each of the years following through year 5). NIPSCO states that the new option is "Revenue Neutral," as required by 170 IAC 1-

6-3(5) to utilize the Commission's 30-Day Filing option.

Customer Impact:

Industrial and Commercial Customers requesting new or increased service requirements that otherwise qualify under the Economic Development Rider and that execute a contract with NIPSCO as

required under the Rider 677.

Tariff Pages Affected:

Rider 677, Economic Development Rider

Staff Analysis:

NIPSCO's supposition that the discount percentages from both options add up to 150% is true; however, changes in the amount of qualifying load over the period a customer is on Rider 677 may produce different results when comparing the two options. None the less, the differences in the two results could go either way and are

believed to be immaterial.
