Under the Heading: TO WHOM AVAILABLE

Northern Indiana Public Service Co.

...This Rate Schedule is available to Industrial Customers with electric metal melting and/or holding equipment and a **maximum thirty (30) minute** on peak Demand for a billing period that is less than 50% of their **maximum thirty (30) minute** off-peak **Demand for that same billing** period and is located adjacent to existing electric facilities adequate to meet the Customer's requirements.

Similar changes are made to the definition under General Terms and Conditions of Service of "2. *On-peak Demand*." The changes include insertions of the clarifying words (in bold):

To the extent Customer has a maximum thirty (30) minute on-peak Demand for a billing period that is greater than 50% of their maximum thirty (30) minute off-peak Demand for that same billing period for three consecutive billing periods then Customer shall not be eligible for this rate schedule and Company shall provide service under another applicable rate schedule.

NIPSCO industrial customers participating in Rate 625.

Rate 625, First Revised, Sheet No. 6 and First Revised, Sheet No. 64

Staff had asked, and NIPSCO complied with specifically notifying all current customers on Rate 625 of the proposed changes. Staff understands that the proposed changes are necessary for a proposed settlement in a docketed proceeding (Cause No. 44291). Staff believes the changes comport with what the types of filings allowed through the Commission's 30-Day Filing rules and recommends approval.
