Request:

To update both the Sales Reconciliation Component ("SRC") and Energy Efficiency Funding Component ("EEFC") in the Energy Efficiency Rider in Appendix I in the Vectren North Tariff for Gas Service.

The residential sales customers (Rate 210) will experience a decrease of 0.93% in their annual bill. The general sales and school transportation customers (Rates 220/225) will experience a decrease of 2.07% in their annual bill.

The Energy Efficiency Rider consists of two components, the SRC and the EEFC. The EEFC recovers certain costs resulting from implementation of the Energy Efficiency Program. The SRC provides the utility with an opportunity to recover its fixed costs even if customer usage declines, allowing the utility to encourage conservation without having its own cost recovery impaired.
