

ORDER GRANTING REQUEST UNDER ADMINISTRATIVE RULE 9(F)(4) FOR RELEASE
OF BULK DATA/COMPILED INFORMATION THAT INCLUDES INFORMATION
EXCLUDED FROM PUBLIC ACCESS UNDER ADMINSTRATIVE RULE 9(G)


Robert Trgovich, Clerk of Court for the United States District Court for the Northern District of Indiana, has submitted a Verified Request under Indiana Administrative Rule 9(F)(4) seeking bulk data or compiled information consisting of the Master List for Jury Pool Assembly. This Master List is sought by Mr. Trgovich in order to make juries in federal court more representative and inclusive. The Master List is currently in the custody of the Court Technology Division of the Office of Judicial Administration. It contains personal data about potential jurors, including names and complete addresses, that are culled from records at the Indiana Bureau of Motor Vehicles (BMV) and the Indiana Department of Revenue (DOR). Information relating to jurors or prospective jurors, other than for the use of parties and counsel is confidential under Jury Rule 10 and excluded from public access under Admin. R. 9(G)(3). Access to bulk or compiled case records excluded from public access may be granted by this Court only under specific circumstances pursuant to Admin. R. 9(F)(4)(c).

The Clerk of the United States District Court for the Southern District of Indiana presented the identical request for access to the Master List for Jury Pool Assembly in November of 2012. At that time the Court examined all of the issues, determined that the prerequisites of Admin. R. 9(F) pertaining to the request were met, and granted the access sought by entry of its order of November 13, 2012. In the order the Court found the same access would be granted to the Clerk of the United States District Court for the Northern District of Indiana if it presented a proper request for access to the information.

The Court further finds that Mr. Trgovich, as Clerk of Court of the United States District Court for the Northern District of Indiana, has presented the Court with a request for access to the Master List for Jury Pool Assembly and that such request is in proper form in accordance with the requirements of Admin. R. 9(F). The Court, therefore, grants the request for Bulk Data/Compiled Information under Admin. R. 9(F)(4) to the extent discussed above.

IT IS, THEREFORE, ORDERED that the Court Technology Division of the Office of Judicial Administration grant to Robert Trgovich, on behalf of the United States District Court for the Northern District of Indiana, access to the Master List for Jury Pool Assembly as described immediately above in this order.
