This brochure is intended as a starting point for resources on Native Americans in the Genealogy Collection of the Indiana State Library. Additional resources on the history of Native Americans can be found throughout the Library.

The Reference & Government Services Collection holds a variety of materials such as federal publications which provide extensive historical information by documenting the relationship between the US government and native peoples.

The Indiana Collection has manuscript holdings showing the interactions between Miamis, Potawatomis, and white settlers; histories and biographies provide additional information about Native Americans who live in Indiana today. Bibliographies from the Indiana Collection's holdings are available from the State Library's website.

The Library's online catalog will identify additional materials that may prove substantial in your research. Librarians are also available to assist you in your needs.


