1	Open Meeting	Meredith Edwards	Review past action items and update statuses 1. MCEs were provided a list of ARC codes. This action item is completed 2. 2020 action calendar has not yet been posted online. Keep as an action item.
2	Project Updates	Ginger and Joyce	Review of Open CR Report MHS asked about the status of the HIP capitation payments for 18 year olds. The CR for that change is 61200. Meredith will discuss with Dennis moving this CR off of "on hold". We would like it to be fixed for when the 2018 and 2019 new capitation rates are run.
3	837D Companion Guide	Rebecca Young	When will DXC update the 837D companion guide to reflect current DXC practices? The guide was updated on 1/24/2020
4	Cost Share Defect	Karen Grays	MCEs submitted examples of errors at the end of November. When will the test results be submitted to OMPP? Defect 17579 cost share file not end dating the previous segment correctly. 12/19/19 went into production. Over 7000 members had data corrected manually for MDwise. MHS stated that cost share responses did look correct. Anthem has not tried to submit. MDwise also has not tried to submit. Testing information was sent to Tara and Meredith on 1/27. Update on the go live plan and clean-up plan for this defect. Meredith will follow up with HIP team on whether MCEs can submit cost share files on days other than the first day of the quarter.
5	Pregnancy and Frail Delays	Tara Morse	IEDSS update Medically Frail delays. There are no changes to the current CST process. A CR has been created for IEDSS to process frail like ICES did – which should mean fewer delays. CR 653495 IEDSS roll out update There are two more waves of rollout for IEDSS. The next one is in September of 2020.
6	New Year PMP Assignment Issue	Rebecca Siewert	Update from DXC on plans to improve process for 2021 DXC stated that the system does not allow updates for the future year during the last quarter. OMPP does not understand why that logic exists and will work with DXC on investigating why that logic is in place and a correction for 2021.
