7	Frail assessment dates changing		CareSource has reported seeing member assessment dates change to 12/31/2299 but then a few months later switch to a calendar date. Is this supposed to happen? CareSource is also reporting that some members have their assessment date changed to years in the past A member has a current assessment but the date changes to 2017/2018 or to the month of. CST has a list of examples. Care Source will send over more examples. MDwise is reporting inconsistencies on members having their frail shut off Examples have been sent to the State.
8	Pay and No Pay responses		CareSource has reported receiving Pay/No Pay responses that state "successfully processed" but that the member segment is not moving to fully eligible plus or basic. CareSource is also reporting that they are seeing Pay/No Pay responses such as "invalid recipient ID", "no pay rejected- recipient in a denied HIP AG", and "AG closed". However the members aren't closed in ICES. Majority of these members are conditional or basic plus. They want to know if they should be sending more members on the list. MHS and Anthem are both having similar issues.
9	PEPW and MAHA files to MCEs		MDwise still receives daily enrollment files for PEPW and MAHA classifications, however the files are empty. Is it permissible for the MCEs to cease loading these files into their systems and sunset their processes MDwise can cease loading the files.
