IHCP to apply cost avoidance for members with LTC insurance and members enrolled in a PE benefit plan

Effective for claims submitted on and after July 21, 2022, the Indiana Health Coverage Programs (IHCP) will begin cost avoiding claims for fee-for-service (FFS) members who have long-term care (LTC) coverage under another insurance policy for the same date of service. Additionally, cost avoidance rules will be applied to members enrolled in a Presumptive Eligibility benefit plan.



These changes require providers to bill all applicable claims to the appropriate third-party liability (TPL) resource prior to submission to the IHCP, or they will deny with one of the explanation of benefits (EOB) codes listed in Table 1.

Table 1 – Explanation of benefits codes for third-party liability

EOB	EOB description
2502	This member is covered by Medicare Part B or Medicare D; therefore, you must first file claims with Medicare. If already submitted to Medicare, please submit your EOMB.
2503	This member is covered by Medicare Part B or Medicare D; therefore, you must first file claims with Medicare.
2505	This member is covered by private insurance which must be billed prior to Medicaid.
