Additional information related to the 2020 annual HCPCS codes update

The Indiana Health Coverage Programs (IHCP) previously announced coverage and billing information for new codes for the 2020 Healthcare Common Procedure Coding System (HCPCS) update in *IHCP Bulletin <u>BT201978</u>*. The IHCP is publishing additional information related to this annual HCPCS update. The additional information and corrections apply retroactively to dates of service (DOS) on or after January 1, 2020, and include the following:



- All laboratory procedure codes (80047–89398) are allowed for podiatry providers as indicated in *Podiatry* Services Codes on the <u>Code Sets</u> page at in.gov/medicaid/providers, with the appropriate Clinical Laboratory Improvement Amendment (CLIA) certification.
- Procedure code L2006 may be reported with revenue code 274 and will be added to *Revenue Codes with* Special Procedure Code Linkages on the <u>Code Sets</u> page at in.gov/medicaid/providers. Providers may submit, resubmit, or adjust fee-for-service (FFS) claims for procedure L2006 affected by this update for DOS on or after January 1, 2020.
- Table 1 presents corrections to information published in BT201978.
- <u>Table 2</u> lists newly covered procedure codes included in the long-term care per diem.
- Table 3 shows discontinued codes included in the 2020 annual HCPCS code updates, along with alternate code considerations. Inclusion of an alternate code on this table does not indicate IHCP coverage of the alternate code. Consult the Professional Fee Schedule, accessible from the <u>IHCP Fee Schedules</u> page at in.gov/medicaid/providers for coverage information. Codes that were discontinued January 1, 2020, for which no alternative codes were identified, are not listed but are available for reference or download from the <u>Centers for Medicaid Services (CMS) website</u> at cms.gov.

BT201978 stated that the IHCP was awaiting the final posting of the CMS Outpatient Fee Schedule and Clinical Laboratory Free Schedule, which could affect pricing for some codes. The IHCP has received this information, which can be found at the following links:
