IHCP announces changes to reimbursement for EMS providers

As announced in *Indiana Health Coverage Programs (IHCP) Bulletin [BT202310](#)*, changes to the reimbursement rates will be effective July 1, 2023. This bulletin provides a correction to the rates published in *BT202310*. Table 1 reflects the rates that will be used effective for dates of service (DOS) on or after July 1, 2023.

As previously published, for DOS on or after July 1, 2023, Medicaid will reimburse these services at the lower rate of the following:

- The provider's submitted charge.
- The allowable amount for that procedure code in the IHCP Professional Fee Schedule in effect for that date of service. The allowable amount is equal to the Medicare urban rate for Indiana as of each Jan. 1, if available.
- If the Medicare urban rate for Indiana is not available, the allowable amount is equal to the IHCP Professional Fee Schedule rate in effect for that date of service, adjusted for inflation as determined by the Office of Medicaid Policy and Planning (OMPP).

Beginning Jan. 1, 2024, the OMPP will use the prior year Medicare rates each year to set the Emergency Medical Services (EMS) rates.

For procedure code A0225, the allowable amount is equal to the IHCP Professional Fee Schedule rate for procedure code A0427. The IHCP Professional Fee Schedule is accessible from the [IHCP Fee Schedules](#) page at in.gov/medicaid/providers.

Changes are effective as of **July 1, 2023**, and apply to the Healthcare Common Procedure Coding System (HCPCS) codes in the table below. Nonemergency ambulance service providers will be reimbursed at the same rates if the service is within the provider's scope of practice.

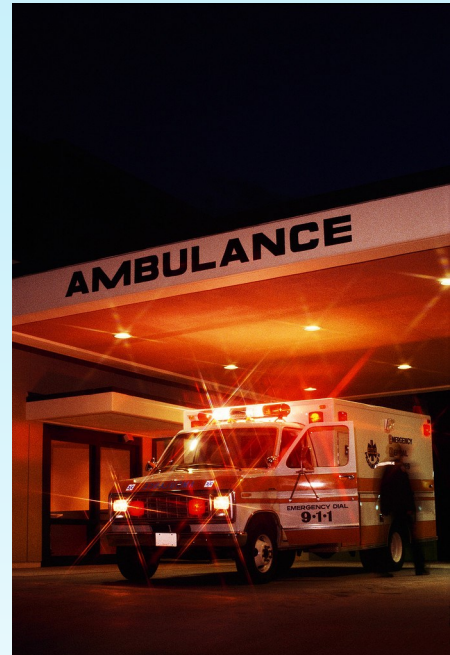

A0425 U2	Ground mileage, per statute mile, BLS	\$8.71
