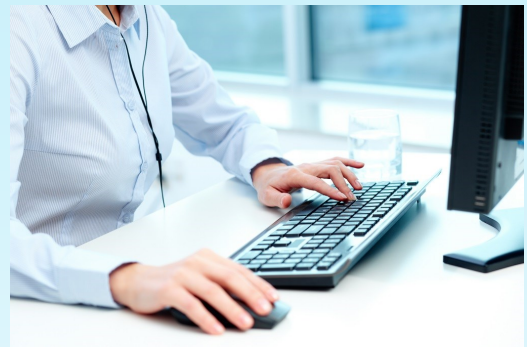

DDRS and IHCP announce changes to day habilitation and prevocational services

The Division of Disability and Rehabilitative Services (DDRS) and Indiana Health Coverage Programs (IHCP) announce that effective May 1, 2023, additional modifiers will be added for day habilitation and prevocational services, to indicate where the service was provided to the member. The previous billing guidance for these services will be end-dated effective April 30, 2023.

When billing for prevocational or day habilitation services that occur on or after May 1, 2023, be sure to include the appropriate modifier for the location where the service was provided. If the service was provided in a facility, select **UF** as the modifier. If the service was provided in a community setting, select **UG** as the modifier. Claims submitted for dates of service (DOS) on or after May 1, 2023, that **do not include** one of the new modifiers for these services will be denied.



Service authorizations/Notices of Action (SAs/NOAs) issued on or after May 1, 2023, will contain a note regarding the new modifier choices to be used when billing. For previously approved services, providers will not receive updated SAs/NOAs until the service period has expired or until other changes are made to the services for the member; however, the UF or UG modifier should be included for these previously approved services as described in this bulletin.

Please make note of the new combinations for billing purposes. Table 1 includes the changes that are effective for DOS on or after May 1, 2023. [Table 2](#) reflects the procedure code/modifier combinations that will be end dated effective April 30, 2023.
